# STAFF REPORT ADOPTION OF PROPOSED 2009 RULEMAKING CALENDAR

## **EXECUTIVE SUMMARY**

## **Background**

Government Code section 11017.6 requires covered state agencies to prepare an annual rulemaking calendar for publication in the California Regulatory Notice Register. While the Commission is exempt from the Office of Administrative Law's (OAL) review and approval, it has traditionally submitted the calendar to keep the public informed of its rulemaking plans. The calendar is due to OAL on February 13, 2009.

# **Proposed 2009 Rulemaking Calendar**

The attached proposed 2009 Rulemaking Calendar consists of one rulemaking:

## Rulemaking 1: General Cleanup Provisions

This rulemaking would amend Title 2, Chapter 2.5, Articles 1 through 6, and Articles 7 through 8.5, sections 1181 through 1186 and sections 1187 through 1189.61 to provide general cleanup to the Commission's regulations. This proposed rulemaking would not amend Article 6.5 regarding Applications for Findings of Significant Financial Distress, or article 8 regarding the Conflict of Interest Code.
