EXECUTIVE SUMMARY

On June 28, 2002, San Juan Unified School District filed a test claim on *Academic Performance Index* (01-TC-22). On August 27, 2007, Commission staff severed Education Code section 52056, subdivision (b), from the *Academic Performance Index* test claim, and titled it *School Accountability Report Cards IV* (01-TC-22A).

On January 8, 2010, claimant requested withdrawal of the severed portion of the test claim titled *School Accountability Report Cards IV.* ¹ Claimant's request was served in writing, and a sixty-day notice of this withdrawal and dismissal was issued pursuant to California Code of Regulations, title 2, section 1183.08.²

No interested parties objected to the claimant's request for withdrawal, or took over the claim by substitution of the parties, on or before March 9, 2010.

Therefore, the sole issue before the Commission on State Mandates (Commission) is whether the Commission adopts the proposed Statement of Decision, dismissing the above-named test claim.³

Recommendation

Staff recommends that the Commission adopt the proposed Statement of Decision, dismissing the severed portion of the test claim titled *School Accountability Report Cards IV*.
