II. Appointment of Commission Legislative Subcommittee Members

Historically, the Commission has maintained a legislative subcommittee to address legislation affecting the mandate determination process. The last proposed legislation affecting the mandates process was SB 856, enacted as Statutes 2010, chapter 856, effective October 19, 2009, which created the mandate redetermination process. Due to the lack of legislative activity affecting the Commission, the Commission has since disbanded the legislative subcommittee. More recently, there have been suggestions by the Department of Finance and legislative staff to look at comprehensive mandate reform. Though no specifics have been
