II. 2014 BUDGET

The Budget Act of 2014 (SB 852) was signed on June 20, 2014. The Commission's budget, as adopted, includes \$1,908,000 to fund the Commission's operations, as originally proposed in the Governor's Budget. The 2014 Budget also includes \$33,817,000 to fund local agency mandates and \$250,735,000 to fund the costs of schools and California community colleges mandate programs pursuant to article XIII B, section 6 of the California Constitution. Additionally, the budget includes \$100 million to pay down the amount owed on pre 2004–05 local agency mandate claims.

Payment of Pre 2004-2005 Local Agency Mandate Debt

Consistent with the proposal in the Governor's May Revise, \$100 million was appropriated for payment of pre 2004-2005 local agency mandate claims. Specifically, the Budget Act of 2014, as adopted, amended Government Code section 17617 to remove fiscal year 2014-2015 from the years in which repayment was prohibited, thus accelerating the repayment of this debt.: It also allocated the appropriation as follows:

No less than 73.1 percent of the \$100,000,000 shall be used for the payment of claims submitted by counties. No less than 24.6 percent of the \$100,000,000 shall be used for the payment of claims submitted by cities. No less than 2.2 percent of the \$100,000,000 shall be used to pay claims submitted by special districts. The Department of Finance's payment instructions shall limit the payment to each city, county, and special district to that city, county, or special district's proportional amount of the total outstanding pre-2004 claims that have been approved for payment. The Controller shall make payments according to the Department of Finance's payment instructions no sooner than 30 days after the Department of Finance has provided the payment schedule to the chairperson of the Joint Legislative Budget Committee or his or her designee.

Additionally, the Governor's 2014 Budget Summary⁷ notes that:

The Budget Act includes a trigger mechanism that makes additional payments for the remaining pre-2004 mandate debt. Additional funds, up to \$800 million, will be provided if estimated General Fund revenues for the 2013-14 and 2014-15 fiscal years at the 2015 May Revision exceed the 2014 Budget Act's estimate for those same revenues. After satisfying the Proposition 98 guarantee, the additional revenues will pay down the remainder of the state's pre-2004 mandate debt.

Election Mandates

Senate Budget Subcommittee 4 opposed the Governor's proposal to suspend eight election mandates.⁸ Ultimately, the conference committee adopted the proposed suspensions. However, the 2014 Budget Act also included the following provision regarding those suspended election mandates:

The Department of Finance shall submit to the Legislature by January 10, 2015, a report that: (1) evaluates simpler mechanisms and alternatives for funding the suspended election mandates; (2) assesses whether some mandated requirements could be modified to realize the same goals at lower costs; and (3) estimates the statewide costs to achieve the goals of the mandate in a cost effective manner. The administration shall consult with the Legislative Analyst's Office and counties in the preparation of this report.

There were no newly suspended local agency mandates in the 2014 Budget.

Treatment of New Education Mandates

While not listed specifically as a funded mandate, *Behavioral Intervention Plans (BIPS)*, CSM-4464 was referenced in provision number 24 under line item "6110-161-0001—For local assistance, Department of Education (Proposition 98), Program 10.60-Special Education Programs for Exceptional Children." Under that provision, the Budget Act of 2014 provides that "the funds appropriated in Schedule (1) [*Special Education Instruction, \$3,213,361,000*] shall first be considered offsetting revenues within the meaning of subdivision (e) of Section 17556 of the Government Code for any reimbursable mandated cost claim for behavioral intervention

plans (CSM 4465) [sic], inclusive of activities performed pursuant to Sections 56521.1 and 56521.2 of the Education Code."

With regard to *Minimum Conditions for State Aid*, 02-TC-25 and 02-TC-31, provision 28 under line item 6870-101-0001 further provides that: "Funding provided to community college districts in Schedule (1) [*Local Assistance Apportionments*, *\$2,059,128,000*] is provided to directly offset any mandated costs claimed by community college districts for the Minimum Conditions for State Aid (02-TC-25 and 02-TC-31) mandated program as determined by the Commission on State Mandates."

Education Omnibus Trailer Bills

The *Education Omnibus Trailer Bills*⁹ amended sections 17581.6 (K-12 Block Grant) and 17581.7 (Community College Block Grant) of the Government Code to include the following new education mandates in the block grant:

Additionally, SB 858 added section 17581.8 to the Government code. This new section appropriates \$287,149,000 and \$49,500,000 to K-12 and community colleges respectively. The new section provides that "[a]llocations made pursuant to this section shall first satisfy any outstanding claims pursuant to Section 6 of Article XIII B of the California Constitution for reimbursement of state-mandated local program costs for any fiscal year." Section 17581.8 also describes the legislature's intent "that school districts will prioritize the use of these one-time funds for professional development, instructional materials, technology infrastructure, and any other investments necessary to support implementation of the common core standards in English language arts and mathematics, the implementation of English language development standards, and the implementation of the Next Generation Science standards."
