## **EXECUTIVE SUMMARY**

On May 26, 2010, claimant requested withdrawal of the test claim filing *Open Meetings Act II* (06-TC-01). Claimant's request was served in writing, and a sixty-day notice of this withdrawal and dismissal was provided pursuant to California Code of Regulations, title 2, section 1183.08.

No interested parties objected to the claimant's request for withdrawal, or took over the claim by substitution of the parties.

Therefore, the sole issue before the Commission on State Mandates (Commission) is whether the Commission adopts the proposed Decision, dismissing the above-named test claim.

#### Recommendation

Staff recommends that the Commission adopt the proposed Decision, dismissing the *Open Meetings Act II* test claim.
