II. BUDGET

Commission's Budget

The 2010-2011 Budget Act (Stats. 2010, ch. 712 (SB 870)) includes \$1,579,000 in funding for the Commission's budget.

Furlough and Leave Programs

The Commission's staff will be on different furlough and leave programs, depending on whether their bargaining units have contracts in place. Five staff members belonging to Bargaining Units 1 and 4 and have tentative contract agreements with the state. Beginning November 2, 2010, these staff members will be subject to a 12-month personal leave program where each employee receives one personal leave day each month for 12 months in lieu of one day of pay per month. During this time period, no further furloughs will be implemented for these employees.

Excluded employees (Chief Counsel, Assistant Executive Director and Executive Director) are also subject to these provisions.

Three staff members belonging to Bargaining Unit 2 have no tentative or final contract in place. Therefore, these employees will continue to be subject to three furlough days per month. The furloughs are self- directed, and the office remains open five days per week.

Other Pay Provisions

All Commission staff are subject to increased retirement contributions, and loss of two paid holidays. Staff with Bargaining Units 1 and 4 and excluded staff will receive two "professional development" days per fiscal year for professional development, and effective July 1, 2013, maximum steps in pay will be increased by 3%.

III. NEW PRACTICES

The Commission adopted amendments to the regulations at the September 30, 2010 hearing that allow for increased electronic filing of documents and posting of documents on the website. Staff is developing policies and procedures for accepting electronic filings and posting them to the website. Staff will conduct a workshop on December 2, 2010 to review the new process, and will implement the new process on January 3, 2011.

IV. SCHEDULING

Test Claims. Commission staff is trying to complete all draft staff analyses that are in progress by early December. These drafts and comments received would then be reviewed by the next executive director before they are issued as final analyses and set for hearing. As these drafts are completed, new test claims will be started for review by the next executive director. We are nearing the end of the infamous 2002 claims that were filed in response to the new statute of limitations.

Incorrect Reduction Claims: Investment Reports. We have proposed an alternative process for resolution of the remaining 70 incorrect reduction claims on the *Investment Reports* program. Earlier this year, the Commission adopted decisions on the County of Los Angeles and the City of Tustin's incorrect reduction claims. To the extent that issues have been decided in these two claims, we understand that the State Controller's Office and some claimants may be willing to resolve pending incorrect reduction claims on the same issues without requiring a Commission staff analysis and hearing on each claim. On remaining issues of first impression, claims will be analyzed and set for hearing if the parties do not reach agreement. So far, we have held meetings with the State Controller's Office and a representative of Maximus to discuss this alternative process. We will meet with the remaining claimant representatives as soon as meetings can be scheduled.

Remaining Incorrect Reduction Claims. As staff resources permit, we will review the remaining 83 pending incorrect reduction claims by program to determine if claims with the same issues can be consolidated for analysis and hearing. It is unlikely that any of these claims will be set for hearing during fiscal year 2010-2011 because of the test claim backlog and the fact that no new positions were added to the Commission's budget this year.
