Dear Ms. Higashi:

The County of San Bernardino is requesting an extension of time for submitting the proposed parameters and guidelines (Ps & Gs) pursuant to the Commission's adoption of the Statement of Decision for the above referenced test claim on January 29, 2004.

The deadline to submit the proposed Ps & Gs to the Commission is initially scheduled on March 22, 2004. Our office is currently working with the County Sheriff's Department to develop and perform a time study for the mandated activities. We intend to incorporate the time study results in the proposed Ps & Gs. The extension of deadline will give us sufficient time to complete development of the time study, allow for an adequate case sampling, compile the results in the proposed Ps & Gs, and submit them for the Commission's review.

As a result, meeting your March 22, 2004 deadline will not be possible for our agency. Thus, the County of San Bernardino is requesting an extension of time, until **June 4, 2004**, for submitting the proposed Ps & Gs for False Reports of Police Misconduct.
