The two test claims listed above share common issues, allegations, and statutes. Specifically, the two statutes and one Education Code section pled in the first claim, *CalSTRS Creditable Compensation*, are also included in the larger filing, *CalSTRS Service Credit*. For the sake of efficiency, the claims shall be consolidated pursuant to my authority under California Code of Regulations, title 2, section 1183.06, effective 10 days from the service of this letter.

For future correspondence, the test claims will be designated *CalSTRS Creditable Compensation/Service Credit*, test claim number 01-TC-02/02-TC-19, Lassen County Office of Education, San Luis Obispo County Office of Education, and Santa Monica Community College District, claimants. A consolidated mailing list is enclosed.

Please note, because the 2002 test claim is not filed on behalf of the same claimants as the 2001 test claim, it is not an "amendment" pursuant to Government Code section 17557, subdivision (d). This could impact potential reimbursement periods for some activities where the test claim allegations vary.
