California Code of Regulations, title 2, sections 1183.1 et seq., states "If proposed parameters and guidelines are not submitted within the 30-day period, and the commission has not granted an extension, then the commission shall notify the test claimant that the amount of reimbursement the test claimant is entitled to for the first 12 months of incurred costs will be reduced by 20 percent, unless the claimant can demonstrate to the commission why an extension of the 30-day period is justified."
