Dear Ms. Halsey:

The State Controller's Office (SCO) requests a second extension from July 17, 2015, to August 7, 2015, for the above-named Incorrect Reduction Claim to respond to the draft proposed decision. This is in addition to the initial extension from June 17, 2015, to July 17, 2015, that you approved.

The proposed decision, dated May 27, 2015, indicates that for the audit period, providing workload data, and showing the classification of employees involved, amount of time spent, and their hourly rate is sufficient support for costs claimed. We believe that such position undermines the SCO's authority to audit costs claimed for validity consistent with statutory and Constitutional provisions. The additional time is requested for good cause to provide our Legal Office with the additional time needed to fully respond to the complex legal issue.


