Pursuant to Title 2, California Code of Regulations section 1187.12, Claimant Los Rios Community College District ("Claimant") hereby notifies the Commission on State Mandates ("Commission") that it is withdrawing the above referenced Incorrect Reduction Claim.

As previously provided in Claimant's October 24, 2014 letter to the Commission, pursuant to the State Controller's Office ("SCO") letter filed on September 4, 2014, the SCO agreed to reinstate to Claimant the entire disputed audit adjustment of \$8,810 for Fiscal Year 1999-2000 and \$10,004 for Fiscal Year 2000-2001. On November 14, 2014, the SCO reissued the audit report reinstating all costs claimed.


