Pursuant to Title 2, California Code of Regulations (“CCR”) section 1187.9(b), Claimant Los Rios Community College District (“Claimant”) respectfully requests a continuance of the Commission on State Mandate’s (“Commission”) hearing on the above referenced Incorrect Reduction Claim (“IRC”), which is currently scheduled for December 5, 2014.

It is respectfully submitted that good cause exists for the granting of the requested continuance. Pursuant to the State Controller’s Office (“SCO”) letter filed on September 4, 2014, the SCO agreed to reinstate to Claimant the entire disputed audit adjustment of \$8,810 for Fiscal Year 1999-2000 and \$10,004 for Fiscal Year 2000-2001. Upon receipt of payment from the SCO of the amounts set forth above or reissuance of the audit reinstating these amounts, a dispute will no longer exist and Claimant will submit a withdrawal of the IRC in accordance with CCR section 1185.8. In the event that the SCO does not reissue the audit and/or pay the amounts set forth above, Claimant will request a rescheduling of the hearing on the IRC.
