Dear Ms. Patton:

This is a request for a two week extension of the deadline by which the Claimants in Santa Ana Region Water Permit – Orange County, 09-TC-03 must submit their rebuttal to comments on the Test Claim made by the California Regional Water Quality Control Board, Santa Ana Region, and the California Department of Finance (collectively “Regional Board”).

California Code of Regulations, title 2, chapter 2.5, section 1183.01, subdivision (c), provides that a party may request an extension of time before the date set for the filing of rebuttal to comments. (Cal. Code Regs., tit. 2, ch. 2.5, § 1183.01, subd. (c)(1).) The Executive Director may approve a request filed by a Claimant for good cause. (*Id.*, at § 1183.01, subd. (c)(1)(B).) Applicable regulations define “good cause” to include, among other things, “the number and complexity of the issues raised.” (Cal. Code Regs., tit. 2 § 1181.1, subd. (h).)


The Claimants request an extension of time of an additional two weeks in which to submit comments due to the number and complexity of the issues raised in the Regional Board’s comments on Test Claim 09-TC-03. The Regional Board’s comments comprise well over a thousand pages, with a narrative section of close to 50 pages. The issues raised are numerous and complex, and required considerable effort to rebut. The response being prepared is a joint response on behalf of all Claimants. Time is needed to provide the Claimants the opportunity to review the joint response.
