Dear Mr. Petersen and Ms. Kanemasu:

On November 15, 2013, the Riverside Unified School District (claimant) filed a revised incorrect reduction claim (IRC) filing with the Commission on State Mandates (Commission) based on the *Notification of Truancy* program for fiscal years 2003-2004 through 2006-2007 in the amount of \$127,968. On December 5, 2013, Commission staff notified the claimant that the filing was incomplete because the State Controller's Office (SCO) complete claiming instructions that were in effect during the fiscal years of the reimbursement claims were not included in the revised filing. On December 16, 2013, the claimant submitted the required complete claiming instructions. Consequently, Commission staff has determined that the IRC filing is now complete.

Furthermore, I am consolidating this revised IRC, 13-904133-I-12 with the existing IRC, 10-904133-I-10 that was filed on November 1, 2010 for the same school district and the same fiscal years. Please refer to the consolidated IRC number 10-904133-I-10 and 13-904133-I-12 in future correspondence.

Government Code section 17551(b) requires the Commission to hear and decide claims by local agencies and school districts that the SCO has incorrectly reduced payments to the local agencies or school districts.

SCO Review and Response. Please file the SCO response and supporting documentation regarding this claim within 90 days of the date of this letter. Please include an explanation of the reasons for the reductions and the computation of reimbursements. All documentary evidence must be authenticated by declarations under penalty of perjury signed by persons who are authorized and competent to do so and be based on the declarant's personal knowledge, information or belief.

The Commission's regulations require that the responses (opposition or recommendation) filed with the Commission be simultaneously served on all parties and interested parties on the mailing list, and accompanied by a proof of service (Cal. Code Regs., tit. 2, 1185.1). However, this requirement may be satisfied by electronically filing your documents via the Commission's

e-filing system. Please see <http://www.csm.ca.gov/dropbox.shtml> on the Commission's website. The responses will be posted on the Commission's website and the mailing list will be notified by electronic mail of the posting. This procedure will satisfy all the service requirements pursuant to section 1181.2 of the Commission's regulations.

The failure of the SCO to respond within this 90-day timeline shall not cause the Commission to delay consideration of this IRC.

Claimant's Rebuttal. Upon receipt of the SCO response, the claimant and interested parties may file rebuttals. The rebuttals are due 30 days from the service date of the response.


Informal Conference. An informal conference pursuant to section 1183.4 of the Commission's regulations may be scheduled if requested.

Public Hearing and Staff Analysis. The public hearing on this claim will be scheduled after the record closes. A staff analysis will be issued on the IRC at least eight weeks prior to the public hearing.

Withdrawal of Incorrect Reduction Claims. Under section 1185.6(a) of the Commission's regulations, an IRC may be withdrawn by written application any time before a decision is adopted or by oral application at the time of hearing. If such an application is made, the Executive Director shall issue a letter dismissing the claim.
