Subject: Request for Extension of Time to Respond to Request for Additional Information Relating to Test Claims 10-TC-01, 10-TC-02, 10-TC-03, 10-TC-05

Dear Ms. Palchik:

The California Regional Water Quality Control Board, San Francisco Bay Region (Regional Water Board) would like to request an extension of time to respond to the Commission's June 15, 2016, request for additional information, to wit, the administrative record for Municipal Regional Stormwater NPDES Permit, Order No. R2-2009-0074 (Order).

California Code of Regulations, title 2, section 1187.9, subdivision (a) allows any party to request an extension of time before a comment or rebuttal deadline has passed, provided the party fully explains the reasons for the extension and proposes a new date for filing. The request shall be granted "[s]o long as postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial." (Cal. Code Regs., tit. 2, § 1187.9, subd. (a).)

Here, the Commission requested that the Regional Water Board file the administrative record for the Order by July 15, 2016. The Regional Water Board staff and supervisors responsible for preparing the record did not receive the request when it was made, and did not become aware that the request *had* been made until after the July 15, 2016, deadline had passed.


Because of this lapse in internal communication, staff have only now begun to prepare the record. Although the agency submitted a basic record for the Order to the Commission in 2011, assembling a complete record will take significant additional staff time. Meanwhile, several supervisors and line staff in the Watershed Management Division responsible for creating the record will be out of the office for much of August. Accordingly, the Regional Water Board requests an extension until September 30, 2016.

Due to the miscommunication described above, the Regional Water Board was unable to file this request for an extension of time before the comment/rebuttal deadline passed, as anticipated by the Commission's regulations. In other respects, however, the request meets the criteria outlined in section 1187.9 and therefore should be approved. The hearings on these test claims are not scheduled until 2017, and the delay in filing the record will not prejudice other

parties or the Commission. To the contrary, the Regional Water Board believes that the information in the record will help the Commission in its decisionmaking, and that the Commission would benefit more from receiving the information late, rather than not at all. Accordingly, the Regional Water Board does not believe there is a good reason to deny its request for an extension.


