R8-2010-0036, EFFECTIVE JANUARY 29, 2010 SAN BERNARDINO COUNTY FLOOD CONTROL DISTRICT, COUNTY OF SAN BERNARDINO, CITIES OF BIG BEAR LAKE, CHINO, CHINO HILLS, COLTON, FONTANA, HIGHLAND, MONTCLAIR, ONTARIO AND RANCHO CUCAMONGA, CO-CLAIMANTS **REQUEST FOR 60 DAY EXTENSION FOR WRITTEN COMMENTS** 

This is a request for a 60 day extension of time in which to submit comments in the above-noted matter. Currently, the Santa Ana Regional Water Quality Control Boards (Santa Ana Regional Boards) comments are due on November 3, 2012. Approval of this 60 day extension would extend the deadline for submitting comments to January 2, 2013.

As you explained in your July 31, 2012 approval of the Santa Ana Regional Boards last request for extension in this matter, while the Executive Director of the Commission *may* approve requests for extension for good cause, extensions by stipulation *shall* be approved for good cause. Further, you suggested that the Santa Ana Regional Board work with the claimants to stipulate for an extension until a particular day. Currently, the Santa Ana Regional Board is engaged in discussions with the claimants that the Santa Ana Regional Boards hopes will result in the placement of the test claim on inactive status--similar to that which has occurred in the Riverside County test claim (10-TC-7).

However, as the parties have not come to agreement on this course of action, the Santa Ana Regional Board requests an additional 60 days within which to prepare and submit comments. I
