SANTA ANA REGIONAL WATER PERMIT – SAN BERNARDINO COUNTY, 10-TC-10 CALIFORNIA REGIONAL WATER QUALITY CONTROL BOARD, SANTA ANA REGION, ORDER NO. R8-2010-0036, EFFECTIVE JANUARY 29, 2010 SAN BERNARDINO COUNTY FLOOD CONTROL DISTRICT, COUNTY OF SAN BERNARDINO, CITIES OF BIG BEAR LAKE, CHINO, CHINO HILLS, COLTON, FONTANA, HIGHLAND, MONTCLAIR, ONTARIO AND RANCHO CUCAMONGA, CO-CLAIMANTS REQUEST FOR 90 DAY EXTENSION FOR WRITTEN COMMENTS

This is a request for a 90 day extension of time in which to submit comments in the above-noted matter. Currently, the Santa Ana Regional Water Quality Control Board's (Santa Ana Regional Board's) comments are due on January 2, 2013. Approval of this 90 day extension would extend the deadline for submitting comments to April 2, 2013.

As you explained in your July 31, 2012 approval of a prior Santa Ana Regional Board request for extension in this matter, while the Executive Director of the Commission may approve requests for extension for good cause, extensions by stipulation shall be approved for good cause. Further, you suggested that the Santa Ana Regional Board work with the claimants to stipulate for an extension until a particular day. Currently, the Santa Ana Regional Board is engaged in discussions with the claimants that the Santa Ana Regional Board's hopes will result in the placement of the test claim on inactive status--similar to that which has occurred in the Riverside County test claim (10-TC-7).

However, as the parties have not come to agreement on this course of action, the Santa Ana Regional Board requests an additional 90 days within which to prepare and submit comments. I have spoken with counsel for the claimants and can represent that the claimants do not object

to the Santa Ana Regional Board's request.
