REQUEST FOR EXTENSION OF TIME TO SUBMIT COMMENTS OF THE STATE WATER RESOURCES CONTROL BOARD AND THE CALIFORNIA REGIONAL WATER QUALITY CONTROL BOARD, SAN DIEGO REGION

By letter dated December 19, 2011, the Commission on State Mandates (Commission) issued a revised notice of complete test claim filing and schedule for comments in the above-referenced matter, with all comments due on or before January 18, 2012. I am the attorney at the State Water Resources Control Board (State Water Board) assigned to this matter and will be preparing comments on behalf of the State Water Board and the San Diego Regional Water Quality Control Board (San Diego Water Board).

The test claim filed by the Co-Claimants is very broad, covering almost every aspect in the challenged permit. In order to respond appropriately, the State and San Diego Water Boards wish to closely evaluate the test claim and the permit provisions alleged to be unfunded state mandates. We anticipate that it will not be possible to complete their review and submit written comments on or before the due date of January 18, 2012. The revised comment period overlapped in large part with a preplanned holiday vacation. In addition, I am the primary attorney assigned to a proceeding in which the San Diego Water Board is considering a complex enforcement action, including an environmental impact report, concerning remediation of sediments in San Diego Bay. The San Diego Water Board is scheduled to consider this

controversial matter at its March 14, 2012, board meeting and preparation for this matter has required and continues to require a significant amount of time.

For these reasons, the State and San Diego Water Boards believe that good cause exists under California Code of Regulations, title 2, section 1181.1, subdivision (h), for granting an extension of time for state agencies to submit comments on the above test claim until **April 18**, **2012.**
