Dear Ms. Halsey:

I am the claimant representative for the Riverside County Flood Control and Water Conservation District, the County of Riverside and the Cities of Murrieta, Temecula and Wildomar (“Co-claimants”). I am writing with regard to your letter of March 8, which indicated that the test claim filed by the Co-claimants on November 10, 2011 was incomplete (“Notice”). The Notice requires a response by **April 7, 2017**.

Since receiving the Notice, the Co-claimants have been reviewing financial records and other resources. Based on that review, the Co-claimants require a short extension of time in order to fully respond to the items identified in the Notice. The Co-claimants therefore respectfully request a 21-day extension of time, to **April 28, 2017**, to respond to the Notice.

As you know, the Commission is scheduled to hear this test claim on December 1, 2017. The Co-claimants are cognizant of the Commission’s desire that filings not be unduly delayed. However, we understand that Commission staff are processing several other test claims that will be heard before this one. The short extension sought in this letter therefore will not delay the work of staff in its consideration of this test claim or require a postponement of the December 1 hearing date. Similarly, there would be no prejudice to any party or interested party from the short requested extension of time.


