On behalf of the County of Los Angeles, I am requesting an extension to submit our rebuttal to the State Controller Office's comments on the above-referenced Incorrect Reduction Claim (IRC).

Due to the time between the time we submitted the claim (August 2013) and the receipt of the comments from State Controller Office (November 2014), the County of Los Angeles requires additional time to re-review our claims and consider the State Controller Office's comments. As Paul McIver, the long-standing administrator of the program, has passed away, we anticipate needing approximately three additional months to prepare the rebuttal.

We respectfully request the Commission grant the County of Los Angeles an extension until March 31, 2015. Our understanding is that the hearing on this matter is scheduled for January 2016; therefore, an extension would not result in a delay in the hearing date. 
