Dear Mr. Hanson:

On June 29, 2015 the Department of Finance filed a request to adopt a new test claim decision to supersede the prior decision on the above-named matter. The Commission is now asking affected state and local agencies and other interested parties to comment on the mandate redetermination request as specified below.

Review of Mandate Redetermination Request

Please focus your comments on the legal issue of whether the state's liability has been modified based on a subsequent change in law. (See generally Gov. Code § 17570 and Cal. Code Regs., tit. 2, §1190.1 et seq.)

Pursuant to section 1190.3 of the Commission's regulations, parties and interested parties may file rebuttals to the written responses within 30 days of service of the comments.

Tentative Hearing Date




