On August 26, 2016, the Commission on State Mandates (Commission) received the County of Los Angeles' requests for reconsideration of the adopted decisions on *Handicapped and Disabled Students II*, 12-0240-I-01, and *Handicapped and Disabled Students*, 13-4282-I-06, pursuant to Government Code section 17559(a) and section 1187.15 of the Commission's regulations, to correct an alleged error of law. These decisions were adopted on July 22, 2016 and served on July 27, 2016.

Notice of Consolidation

Pursuant to the executive director's duty under Government Code section 17530 to expedite all matters within the jurisdiction of the Commission, and because they raise the same legal issue


and allege the same error of law, these two requests are being consolidated for purposes of the first hearing only to determine whether the Commission should grant the requests for reconsideration pursuant to section 1187.15(f) of the Commission's regulations. If the Commission grants the requests for reconsideration, a second hearing will be conducted pursuant to section 1187.15(g) to determine if the adopted decisions on each of the two IRCs must be revised to correct an error of law. If a second hearing is ordered by the Commission, these matters will be heard individually.

Notice of Hearing

The Commission will consider whether the requests for reconsideration should be granted at the Commission hearing on **September 23, 2016**. Pursuant to section 1187.15(f) of the Commission's regulations, Commission staff will prepare a written analysis for the September 23, 2016 hearing and recommend whether the requests for reconsideration should be granted. Five affirmative votes shall be required to grant the requests for reconsideration.

If the Commission grants the requests for reconsideration at the September 23, 2016 hearing, Commission staff will prepare, issue for comment, and set for hearing draft proposed decisions addressing whether the prior final decisions are contrary to law and, if so, recommending how to correct the error of law.
