### Dear Mr. Petersen:

The Commission has issued the enclosed statement of decision, draft staff analysis, and proposed parameters and guidelines for the above-named matter. The proposed parameters and guidelines include six sets of proposed parameters and guidelines, and the amended parameters and guidelines for *Pupil Suspensions from School*, *Pupil Expulsions from School*, and *Pupil Expulsion Appeals*.

Please note that the statement of decision indicated that two activities are effective January 1, 1996: (1) providing a notice of the education alternative placement to the pupil or pupil's parent or guardian at the time of the expulsion order, (§ 48918, subd. (j)); and (2) the one-time activity for school districts to amend their expulsion rules and regulations to provide for issuing subpoenas, (§48918, subd. (i)). Although the January 1, 1996 date is technically correct, the statute was operative July 1, 1996 because it was enacted as Statutes 1995, chapter 974. Since the operative date is when reimbursement for these activities would begin, the attached parameters and guidelines reflect the July 1, 1996 operative date.
