On January 11, 2001, the claimant requested an extension of time to file a reply to the Department of Finance's comments regarding activities the Department contends are suspended under Government Code section 17581. The constitutionality of Government Code section 17581 is the issue in *Carmel Valley Fire Protection District v. State of California*, a case currently pending with the California Supreme Court. The claimant requests an extension until 30 days after the California Supreme Court renders its decision in *Carmel Valley* to file its reply.

The claimant's request is granted. Staff will issue a hearing and comment schedule following receipt of the California Supreme Court's decision in *Carmel Valley*.
