PROPOSED AMENDMENTS TO CALIFORNIA CODE OF REGULATIONS, TITLE 2, DIVISION 2, CHAPTER 2.5

ARTICLE 9

SECTION 1189.10 GENERAL PROVISIONS AND APPENDIX

EXECUTIVE SUMMARY

Section 1188.1(a) of the Commission on State Mandates' (Commission's) regulations authorizes the Commission to adopt an order to initiate rulemaking. Following adoption of the order, staff will publish a notice of hearing and notice and rulemaking package to all interested persons for public comment.

The purpose of this rulemaking is to update the Commission's Conflict-of-Interest Code to add two positions to the list of designated positions and a new disclosure category. Specifically, the proposed regulation amends the Appendix to section 1189.10 of the Conflict-of-Interest Code by: (1) adding the Attorney IV and Office Technician positions to the list of designated positions and assigning disclosure categories to these positions; and (2) adding Category 4 to the disclosure categories. Category 4, which requires disclosure of economic interests in any source which contracts with the Commission for the provision of goods and does not require disclosure of economic interests in real property, applies to the Office Technician position because the Office Technician participates in making procurement decisions pertaining to goods only.

These changes are discussed in detail in the attached Initial Statement of Reasons.¹
