Hearing

This matter is set for hearing on Friday, January 27, 2023, at 10:00 a.m., via Zoom.

Statutes 2022, chapter 48 (Sec. 20 and 80), signed by Governor Newsom on June 30, 2022, amended the Bagley-Keene Open Meeting Act to extend until July 1, 2023, the authority to hold public meetings through teleconferencing and to make public meetings accessible electronically to all members of the public seeking to observe and to address the state body in order to protect the health and safety of civil servants and the public. The statute further suspends and no longer requires until July 1, 2023, the physical presence of members or other personnel of the state body or the public as a condition of participation in or quorum for a public meeting; the identification of each teleconference location from which a member will be participating; the posting of the notice and agenda at each teleconference location; and the ability of the public to address the state body at each teleconference location

STAFF ANALYSIS

Summary of the Mandate, Eligible Claimants, and Period of Reimbursement

Elections Code sections 21532 and 21534, as added by Statutes 2016, chapter 781 (SB 958), require the County of Los Angeles to create, staff, and fund the independent County of Los Angeles Citizens Redistricting Committee (CRC) to adjust the boundary lines of the supervisorial districts in the County of Los Angeles in the year following the year of the decennial federal census.

The Commission adopted the Test Claim Decision on May 28, 2021, and the Decision and Parameters and Guidelines on December 3, 2021, approving reimbursement for the only eligible claimant, the County of Los Angeles.

The initial reimbursement period is July 1, 2018, through June 30, 2021 (fiscal years 2018-2019, 2019-2020, and 2020-2021). The County of Los Angeles was required to file initial claims with the State Controller's Office (Controller) by October 27, 2022. Late initial reimbursement claims may be filed until October 27, 2023, but will incur a 10 percent late filing penalty of the total amount of the initial claim without limitation.¹

Reimbursable Activities

As stated in the Parameters and Guidelines, the Commission approved the following reimbursable activities for this program:

A. One time training for each CRC member on the Rosenberg Rules of Order and format of public hearings, and the ethics requirements of CRC members, which pursuant to Elections Code section 21532, requires the member to be impartial and apply legal requirements.

Reimbursement is **not** required to adjust supervisorial boundary lines and adopt a redistricting plan in accordance with the Voting Rights Act, or for training regarding the Ralph M. Brown Act, the California Public Records Act, or any other activities not identified in Section IV.B. of these Parameters and Guidelines.

- B. Ongoing Activities
- 1. Creation of the Citizens Redistricting Commission (CRC).²
 - a. The county shall create a CRC no later than December 31, 2020, and in each year ending in the number zero thereafter.³
 - b. The elections official shall review the applications and eliminate applicants who do not meet the specified qualifications, select 60 of the most qualified applicants, publish the list of qualified applicants for 30 days, and create a subpool for each of the five existing supervisorial districts of the board.⁴
 - c. At a regularly scheduled meeting of the board, the Auditor-Controller conducts a random drawing to select one commissioner from each of the five subpools, then another random drawing from all of the remaining applicants to select three additional commissioners.⁵
 - d. The board shall take all steps necessary to ensure a complete and accurate computerized database is available for redistricting, and that procedures are in place

to provide to the public ready access to redistricting data and computer software equivalent to what is available to the CRC.⁶

- 2. Activities Performed by the CRC.⁷ Based on Elections Code section 21534(c)(8), which requires the County of Los Angeles to provide reasonable funding and staffing to the CRC, the following activities mandated by the test claim statute and performed by the CRC are eligible for reimbursement:
 - a. The eight selected commissioners shall review the remaining names in the subpools of applicants and shall appoint six additional applicants to the CRC.⁸ Reimbursement for this activity includes the following:
 - Design a selection process to appoint the six CRC members.
 - Conduct and tabulate surveys of CRC member evaluations of the applicants for the six remaining seats.
 - Facilitate CRC meetings to select the final six CRC members.
 - Select replacement commissioners in accordance with Elections Code 21532 for CRC members that resign to ensure a 14-member commission and a quorum are maintained.
 - Conduct seven public hearings before drafting a map, to take place over a period of no fewer than 30 days, with at least one public hearing held in each supervisorial district.⁹

Reimbursement is **not** required to comply with the Ralph M. Brown Act when conducting these hearings pursuant to article XIII B, section 6(a)(4) of the California Constitution. Thus, the following activities are not eligible for reimbursement: posting a notice and agenda (Government Code section 54954.2), mailing agenda items to the public (Government Code section 54954.1), and complying with the Americans with Disabilities Act for the hearing (54953.2).

b. Post the draft map for public comment on the website of the County of Los Angeles and conduct one public hearing on the draft map (in addition to the one hearing required under prior law, which is not reimbursable).¹⁰

Reimbursement is **not** required to comply with the Ralph M. Brown Act when conducting the hearing on the draft map pursuant to article XIII B, section 6(a)(4) of the California Constitution. Thus, the following activities are not eligible for reimbursement: posting a notice and agenda (Government Code section 54954.2), mailing agenda items to the public (Government Code section 54954.1), and complying with the Americans with Disabilities Act for the hearing (54953.2).

- c. Establish and make available to the public a calendar of the eight public hearings identified in Section IV.B.2.b. and c. of these Parameters and Guidelines.¹¹
- d. Arrange for the live translation of a hearing in an applicable language (defined as "a language for which the number of residents of the County of Los Angeles who are members of a language minority is greater than or equal to three percent of the total voting age residents of the county") if a request for translation is made at least 24 hours before the hearing.¹²
- e. Take steps to encourage county residents to participate in the redistricting public review process. Reimbursement for this activity includes the following:
 - Develop and implement a Public Outreach Plan to increase public participation.
 - Provide information through media, social media, and public service announcements.
 - Coordinate with community organizations.
 - Post information on the Internet Web site of the County of Los Angeles that explains the redistricting process and includes a notice of each public hearing and the procedures for testifying during a hearing or submitting written testimony directly to the CRC.¹³
- f. Issue a report that explains the basis on which the CRC made its decisions in achieving compliance with the redistricting criteria required to comply with the Voting Rights Act.¹⁴

Offsetting Revenues and Reimbursements

The Parameters and Guidelines specify that any offsetting revenue the claimant experiences in the same program as a result of the same statutes or executive orders found to contain the mandate shall be deducted from the costs claimed. In addition, reimbursement for this mandate from any source, including but not limited to, service fees collected, federal funds, other state

funds, and other funds that are not the claimant's proceeds of taxes shall be identified and deducted from this claim.¹⁵ The County identified no offsetting revenue.

Statewide Cost Estimate

Staff reviewed two unaudited reimbursement claims submitted by the County of Los Angeles compiled by the Controller and developed the Statewide Cost Estimate based on the assumptions and methodology discussed herein. Although the potential initial reimbursement period covered three fiscal years, the County first began incurring costs on July 1, 2019.¹⁶ Thus, the County only filed claims for fiscal years 2019-2020 and 2020-2021. Table 1 and Table 2, below, summarize the costs for the initial reimbursement period and the cost estimates for the period that includes the next decennial federal census, respectively.

Assumptions

- 1. The test claim statute imposes requirements solely on the County of Los Angeles. Thus, the County is and will remain the only eligible claimant.
- 2. The amount claimed for the initial reimbursement period may increase if amended claims are filed.
- 3. Actual costs may be lower following an audit by the Controller because the claims appear to include some activities that were denied by the Commission. Specifically, the County claimed the costs of the following activities that were denied by the Commission:
 - the costs of the Esri software license in the amount of \$39,500.¹⁷
 - the costs of Thai Le to provide GIS support in the amount of \$1,387.50.¹⁸

The Commission denied reimbursement for these activities because mapping has always been part of redistricting and is not a new activity.¹⁹

 costs for independent counsel to attend ten meetings of the CRC, from December 14, 2020 through May 26, 2021, under activities B.1.a., B.2.d., and B.2.f. in the amount of \$10,472.50.²⁰

The Commission denied reimbursement for the meetings of the CRC because the meetings go beyond the scope of the mandated program.²¹ Thus, the costs of meetings are not eligible for reimbursement.

• costs of independent counsel to the CRC under activity B.1.d. in the amount of \$51,335.50. Activity B.1.d. requires the County Board of Supervisors to ensure a complete and accurate computerized database is available for redistricting and to provide the public ready access.²²

The Commission denied reimbursement for the activities of County Counsel to retain independent counsel for the CRC to preserve the independence of the CRC and to develop the CRC's by-laws because these activities were not supported by substantial evidence in the record.²³

The claimed amounts for what appears to be denied activities total \$102,695.50, which could reduce the initial claims to \$965,113. This will need to be reviewed and determined by the State Controller.

- 4. The test claim statute requires eight public hearings before the adoption of the final map. Prior law required one public hearing. Thus, the costs for only seven public hearings are reimbursable.²⁴ The CRC held 16 public hearings between June 14, 2021 and December 7, 2021.²⁵ The County of Los Angeles claimed costs for the three hearings during fiscal year 2020-2021.²⁶ Thus, the County can only claim the costs of a maximum of four public hearings held during fiscal year 2021-2022.
- 5. The County of Los Angeles claimed no indirect costs in the initial claims. Accordingly, the Commission projects no indirect costs for fiscal year 2021-2022.

6. The test claim statute requires the County of Los Angeles to create, staff, and fund a CRC at the time of each federal census.²⁷ The current commissioners' terms expire upon the appointment of the first member of the succeeding CRC.²⁸ However, the mandated activities end when the CRC issues a final map and a final report that explains the basis on which the CRC made its decisions in achieving compliance with the redistricting criteria required to comply with the Voting Rights Act.²⁹ This report, issued on December 15, 2021, sets forth the CRC's compliance with the test claim statute to establish boundary lines for the five supervisorial districts in the County including: the selection of CRC members,³⁰ public outreach to ensure community involvement,³¹ public hearings on the proposed maps,³² and the application of the redistricting criteria to the final map.³³ The reimbursable activities were completed and culminated in the adoption of a final map and the final report. Although the current CRC has completed its redistricting, it recommended that it continue meeting to improve the process by incorporating lessons learned to provide future CRCs a head start,³⁴ which might involve: 1) implementing a robust outreach and engagement $plan^{35}$ and 2) continuously educating the public regarding the Voting Rights Act and redistricting criteria.³⁶ The reimbursable activities listed under Activity B.2.f., above, regarding outreach and providing information to the public are limited to encouraging county residents to participate in the "redistricting public review process."³⁷ Redistricting is the apportionment of legislative representation based on population as based upon the results of the federal census.³⁸ Thus, in the years between the federal censuses, there is no ongoing redistricting

process or public review process.³⁹ Therefore, the current CRC, acting on its lessons learned, would not be performing any reimbursable activities.

7. For the initial claiming period, the County received applications for CRC membership on September 8, 2020, and the first eight CRC members were chosen on November 24, 2020.⁴⁰ In its final report, the current CRC recommended that the first eight members should be chosen no later than September 1 of the year in which the census takes place or, if the subsequent CRC is to select its own Executive Director or independent legal counsel, then the first eight members should be chosen no later than June 1.⁴¹ If this recommendation is followed and the process takes the same amount of time as it did during the initial claiming period, then the applications would need to be received by June 16, 2030, to choose the members by September 1, or by March 9, 2030, to choose the members by June 1. Thus, the County would begin incurring costs for the mandated activities under the next redistricting process by choosing the CRC in fiscal year 2029-2030. No costs are reimbursable between the issuance of the first final report, and the creation of the next CRC in fiscal year 2029-2030.

Methodology

A. Initial Reimbursement Period Cost Estimate:

The statewide cost estimate for the initial reimbursement period totals **\$965,114 - \$1,067,809**.

Activity A.1.: Activity A.1. consists of one-time training for each CRC member on the Rosenberg Rules of Order and format of public hearings, and the ethics requirements of CRC members. The costs for Activity A.1. are the costs actually claimed for that activity: \$0.

Activity B.1.a.: Activity B.1.a. consists of creating a CRC no later than December 31, 2020, and in each year ending in the number zero thereafter. The high end of the costs for Activity B.1.a. are the costs actually claimed for that activity. The low end assumes an audit by the Controller disallows costs for denied activities: \$190,173 - \$195,572.

Activity B.1.b.: Activity B.1.b. consists of the elections official reviewing the applications and eliminating applicants who do not meet the specified qualifications. Then, the elections official selects 60 of the most qualified applicants, publishes the list of qualified applicants for 30 days, and creates a subpool for each of the five existing supervisorial districts of the board. The costs for Activity B.1.b. are the costs actually claimed for that activity: \$18,066.

Activity B.1.c.: Activity B.1.c. consists of the Auditor-Controller, at a regularly scheduled meeting of the board of supervisors, conducting a random drawing to select one commissioner from each of the five subpools, then another random drawing from all of the remaining

applicants to select three additional commissioners. The costs for Activity B.1.c. are the costs actually claimed for that activity: \$11,195.

Activity B.1.d.: Activity B.1.d. consists of the board of supervisors taking all steps necessary to ensure a complete and accurate computerized database is available for redistricting, and that procedures are in place to provide to the public ready access to redistricting data and computer software equivalent to what is available to the CRC. The high end of the costs for Activity B.1.d. are the costs actually claimed for that activity. The low end assumes an audit by the Controller disallows costs for denied activities: \$271,544 - \$362,379.

Activity B.2.a.: Activity B.2.a. consists of the eight commissioners selected by the Auditor-Controller reviewing the remaining names in the subpools of applicants and appointing six additional applicants to the CRC which includes the following activities:

- Designing a selection process,
- Conducting and tabulating surveys of CRC member evaluations of the applicants,
- Facilitating the CRC meetings to select the final six CRC members, and
- Selecting replacement commissioners for CRC members that resign.

The costs for Activity B.2.a. are the costs actually claimed for that activity: \$3,584.

Activity B.2.b.: Activity B.2.b. consists of the CRC conducting seven public hearings — over no fewer than 30 days and at least one in each supervisorial district — before drafting a map. The costs for Activity B.2.b. are the costs actually claimed for that activity: \$62,074.

Activity B.2.c.: Activity B.2.c. consists of the CRC posting the draft map for public comment on the website of the County of Los Angeles and conducting one public hearing on the draft map. The costs for Activity B.2.c. are the costs actually claimed for that activity: \$0.

Activity B.2.d.: Activity B.2.d. consists of the CRC establishing and making available to the public a calendar of the eight public hearings. The high end of costs for Activity B.2.d. are the costs actually claimed for that activity. The low end assumes an audit by the Controller disallows costs for denied activities: \$52,579 - \$54,780.

Activity B.2.e.: Activity B.2.e. consists of the CRC arranging for the live translation of a hearing in an applicable language (defined as "a language for which the number of residents of the County of Los Angeles who are members of a language minority is greater than or equal to three percent of the total voting age residents of the county") if a request for translation is made at least 24 hours before the hearing. The costs for Activity B.2.e. are the costs actually claimed for that activity: \$0.

Activity B.2.f.: Activity B.2.f. consists of the CRC taking steps to encourage county residents to participate in the redistricting public review process, which includes:

- Develop and implement a Public Outreach Plan to increase public participation.
- Provide information through media, social media, and public service announcements.
- Coordinate with community organizations.
- Post information on the Internet Web site of the County of Los Angeles that explains the redistricting process and includes a notice of each public hearing and the procedures for testifying during a hearing or submitting written testimony directly to the CRC.

The high end of the costs for Activity B.2.f. are the costs actually claimed for that activity. The low end assumes an audit by the Controller disallows costs for denied activities: \$355,899 - \$360,159.

Activity B.2.g.: Activity B.2.g. consists of the CRC issuing a report that explains the basis on which the CRC made its decisions in achieving compliance with the redistricting criteria required to comply with the Voting Rights Act. The costs for Activity B.2.g. are the costs actually claimed for that activity: \$0.

Indirect Costs: The indirect costs actually claimed are \$0.

Offsetting Revenues: The total offsetting revenues actually claimed are \$0.

Late Filing Penalties: The penalties are \$0 because the initial claims were not assessed a late filing penalty.

B. Costs of \$88,777 Are Projected for Fiscal Year 2021-2022:

As noted above, the test claim statute requires the County to create, staff, and fund a CRC at the time of each federal census to address the redistricting of the supervisorial districts of the County. During the 2021-2022 fiscal year, the current CRC held 13 public hearings on the proposed maps and issued its report on December 15, 2021.⁴² However, as explained above, the costs for a total of seven public hearings are reimbursable.⁴³ In the initial claims, the County claimed costs of \$62,074 for holding three of the seven reimbursable public hearings in fiscal year 2020-2021 (\$20,691 per hearing) and \$6,013 for CRC staff to collect and post information on its website.⁴⁴ The Commission projects costs of \$82,764 for holding the remaining four reimbursable public hearings in the first half of 2021-2022 (\$20,691 x 4) and \$6,013 for issuing the final report by posting it online. These amounts could be lower following an audit by the Controller. For example, it is not clear from the reimbursement claims if the claimant included costs to comply with the Brown Act and the Americans with Disabilities Act for the public hearings, which are not reimbursable under this program.

The next federal census will be in 2030 at which time the members of the new CRC will be chosen. Thus, the County will not incur additional reimbursable costs until fiscal year 2029-2030. Accordingly, the Commission projects costs to the State of \$88,777 in fiscal year 2021-2022 and then costs similar to those in this estimate plus the implicit price deflator, for the 2029-2030, 2030-2031, and 2031-2032 fiscal years.

Draft Proposed Statewide Cost Estimate

On December 9, 2022, Commission staff issued the Draft Proposed Statewide Cost Estimate, with comments due on December 19, 2022.⁴⁵ No comments were filed on the Draft Proposed Statewide Cost Estimate.

Staff Recommendation

Staff recommends that the Commission adopt this Statewide Cost Estimate of \$965,114 - \$1,067,809 for the Initial Claim Period (Fiscal Years 2018-2019, 2019-2020, and 2020-2021) and \$88,777 for fiscal year 2021-2022. Staff also estimates \$0 in reimbursable costs for fiscal years 2022-2023 through 2028-2029. Then, staff estimates that the County of Los Angeles will next incur reimbursable costs totaling \$1,053,891 - \$1,156,586 plus the implicit price deflator for fiscal years 2029-2030, 2030-2031, and 2031-2032 combined, for the next round of redistricting.
