ADOPTION OF PROPOSED 2022 RULEMAKING CALENDAR

EXECUTIVE SUMMARY

Background

Government Code section 11017.6 requires covered state agencies to prepare an annual rulemaking calendar for publication in the California Regulatory Notice Register. While the Commission on State Mandates (Commission) is exempt from review and approval by the Office of Administrative Law (OAL), it has traditionally submitted the calendar to keep the public informed of its rulemaking plans. The calendar is due to OAL before February 14, 2022.

Proposed 2022 Rulemaking Calendar

The attached Proposed 2022 Rulemaking Calendar consists of three rulemakings.

The first is for the Order to Initiate Rulemaking 21-02: Amendment to Conflict of Interest Code which was adopted by the Commission on January 22, 2021. Rulemaking 21-02 did not complete preliminary Fair Political Practices Commission (FPPC) review as originally adopted by the Commission, therefore was not commenced with the Office of Administrative Law (OAL).

Order 22-01: Amendment to Conflict of Interest Code

This rulemaking would amend Title 2, Chapter 2.5, Article 9 to provide an update to the Commission's Conflict of Interest Code.
