CALL TO ORDER AND ROLL CALL

Chairperson Miller called the meeting to order at 10:00 a.m. Executive Director Heather Halsey stated that Member Olsen let Commission staff know that she was unable to attend the hearing; welcomed and introduced a new Commission employee, Marie Jacques; and called the roll.

ELECTION OF OFFICERS

Chairperson Miller asked for nominations for chairperson. Member Wong-Hernandez nominated the Director of Finance, as chairperson. With a second by Member Hariri, the Director of Finance was elected chairperson by unanimous voice vote with Member Olsen absent.

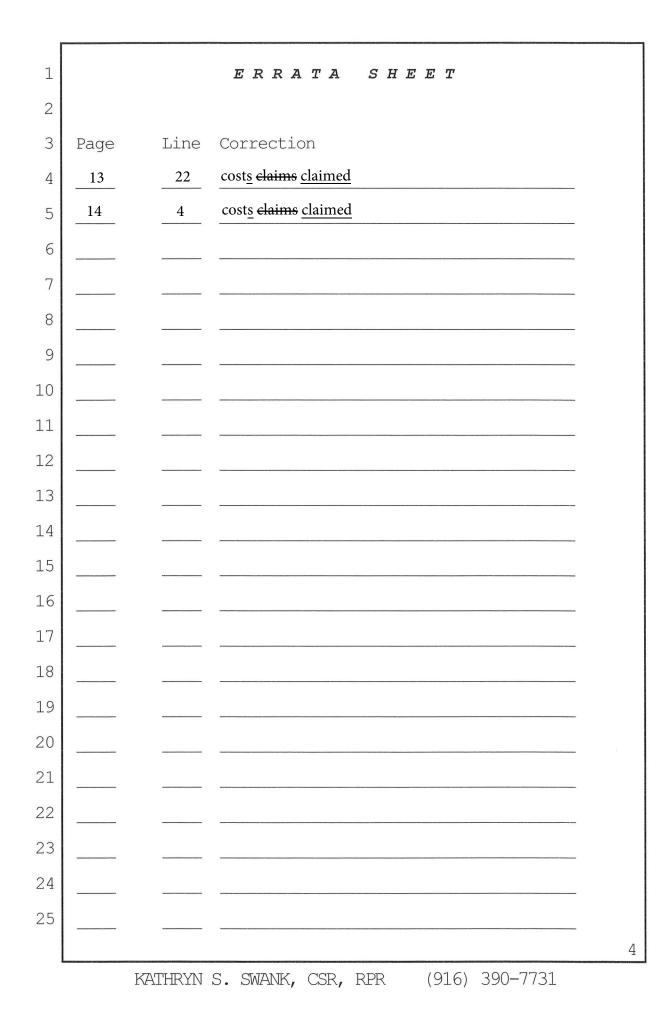

1 Staff finds the IRC was timely filed and that the audit of the 09/10 amended claim was timely initiated. 2 3 Staff also finds that the Controller's reductions are 4 correct as a matter of law because the cost claims were 5 not supported with the documentation required by the 6 parameters and guidelines and the claim had failed to 7 identify and deduct as offsetting revenue the local 8 school construction bond funds. 9 The Controller agrees with the proposed decision, 10 but the claimant does not. 11 Accordingly, staff recommends the Commission adopt 12 the proposed decision to deny this IRC and authorize 13 staff to make any technical, nonsubstantive changes to the proposed decision following the hearing. 14 15 CHAIRPERSON MILLER: Great. Thank you very much. 16 Could you please state your full name, sir. 17 MR. RYAN: Chris Ryan, audit manager at the State 18 Controller's Office. 19 CHAIRPERSON MILLER: Any comments on this item? 20 MR. RYAN: The State Controller's Office supports 21 the staff's conclusion and recommendation. 22 CHAIRPERSON MILLER: Thank you very much, Mr. Ryan. 23 Is there any further public comment on this item? 24 (No response) 25 CHAIRPERSON MILLER: No? Are there any questions

2 MEMBER WONG-HERNANDEZ: I have a question.

3 CHAIRPERSON MILLER: Yes, Ms. Wong-Hernandez. 4 MEMBER WONG-HERNANDEZ: I noticed, obviously, that 5 this is dealing with the same mandate that the CSBA case 6 that was decided was recently dealing with. I know it's 7 different years. But I was -- I was hoping, at some point, whether it's here or in closed session to sort of 8 9 hear about any potential interaction with this. I'm 10 trying to figure sort of, if the claimant doesn't agree, 11 why they are not here, if they are seeing some sort of 12 interaction. And I don't know if you can opine on that. 13 MS. SHELTON: Well, this IRC presents issues that 14 are far different than those issues presented in the 15 CSBA case. The CSBA case is really dealing with 16 offsetting revenues that are particular to statutes that 17 are not at issue at all in this incorrect reduction 18 claim.

MEMBER WONG-HERNANDEZ: Okay. But my only other question was, do we typically -- have we, in the past, said that any kind of local bond measures where they are getting school facilities funding locally is not something -- that that is an offsetting revenue? Because I thought I understood that that's one of the audit findings from this.

1	January 6, 2020. At this time, there are no new
2	Mandates-related bills to report. However, the
3	Commission continues to monitor the following three
4	bills:

5 First, SB 287, Commission on State Mandates, Test 6 Claims, Filing Date, which proposes language that would 7 specify that for purposes of filing a test claim, based 8 on the date of incurring increased costs, the phrase 9 "within 12 months" means by June 30 of the fiscal year 10 following the fiscal year in which increased costs were 11 first incurred by the test claimant. This bill is still 12 being held in Assembly Committee under submission.

13 Next, AB 400, State Mandates, which according to14 the author's office, is a spot bill.

Finally, AB 1471, State-Mandated Local Costs, Notification, proposes language that would specify that reimbursement of lost revenue be provided to certain local agencies as a result of delayed state action pursuant to the same procedures as filing a test claim with the Commission.

Also, the provisions of this bill would be exempt from the exceptions under Government Code section 17556. The bill did not make it out of its house of origin by the deadline, and, as a result, it still could become a two-year bill and be acted on this year. We will

continue to monitor for legislation that impacts the
 mandates process.

CHAIRPERSON MILLER: Thank you very much for that.
And now we will move to Item Number 8, please.
MS. HALSEY: Chief Legal Counsel Camille Shelton
will present Item 8, the Chief Legal Counsel Report.
MS. SHELTON: Good morning.

8 There are no new filings, and we do have a recent 9 decision, as we indicated, from the California School 10 Board Association matter versus the Commission on State 11 Mandates.

12 On December 19th, 2019, the California Supreme 13 Court issued its opinion denying CSBA's petition. The 14 court found that the state does not violate Article XIII 15 B, section 6, of the California Constitution when it 16 identifies general education funding it already provides 17 to school districts and county offices of education, as 18 offsetting revenue for the purpose of reimbursing State 19 Mandates; and that the State does not violate separation 20 of powers principles when it allows general education 21 funding or special education funding to be identified as 22 offsetting revenues for state-mandated programs.

This case will be remanded back to the Alameda
County Superior Court to resolve the remaining issues.
We do have several cases on the litigation hearing

calendar: The first one, on the challenge to the
 Commission's decision on discharge of stormwater runoff,
 the superior court did hear that matter on remand on
 December 6, 2019. But on January 2nd, 2020, the court
 issued a request for additional briefing to be filed by
 January 31st, after which the court may schedule a
 second hearing or issue its final ruling.

8 We -- the Third District Court of Appeal has 9 noticed the parties and set the hearing for minimum 10 conditions for state aid. That one is a challenge by 11 Coast Community College District. It's pending in the 12 Third District Court of Appeal, and the hearing date is 13 March 16, 2020.

And, finally, the hearing for City of San Diego
versus Commission on State Mandates, which challenges
the Commission's decision in lead sampling in schools,
has been scheduled for May 8th, 2020, in the Sacramento
County Superior Court.

19 CHAIRPERSON MILLER: Thank you. And all of those 20 are streamed now, right? If anybody is interested in 21 watching them.

22 MS. SHELTON: No. The streaming only occurs in the 23 Supreme Court, not in the lower courts yet.

CHAIRPERSON MILLER: Okay. Great. Thank you verymuch.

2	Ms. Halsey, the Executive Director Report.
3	MS. HALSEY: Yes.
4	After this hearing, there are 41 pending test
5	claims, 39 of which are regarding stormwater NPDES
6	permits, and one parameters and guidelines amendment on
7	graduation requirements, which is now pending inactive.
8	We also have two statewide cost estimates pending
9	inactive, and there's one additional parameters and
10	guidelines and one additional statewide cost estimate,
11	which are both regarding the stormwater NPDES permits,
12	and those are on inactive status pending the outcome of
13	litigation regarding the test claim decisions underlying
14	those matters.
15	We also have one request for mandate
16	redetermination currently pending, which is on remand
17	from the court.
18	And, finally, there are five remaining IRCs.
19	Commission staff currently expect to complete all
20	the currently pending test claims and IRCs by
21	approximately the March 2023 Commission meeting
22	depending on staffing and other workload.
23	And as noted last meeting, two of the Commission
24	senior staff attorneys have separated from the
25	Commission, and we are currently working on recruiting
	22

to fill those positions, and this is taking some time.
 Additionally, some of the test claims may be heard
 and decided earlier than currently indicated if they are
 consolidated for hearing.

5 Please check the tentative agenda items on my
6 Executive Director's report to see if an item you are
7 interested in is coming up in the next few hearings.

And, also, a reminder to please notify Commission staff not later than the Wednesday prior to a hearing that you, or a witness that you are bringing, plan to testify, and please include the names of the people who will be speaking for inclusion on the witness list, as staff is no longer sending reminder e-mails.

And finally, I would like to ask Senior Commission Counsel Eric Feller and Chief Legal Counsel Camille Shelton to make their way to the claimant's side of the table so that Ms. Shelton may present Mr. Feller with an award in recognition of his 25 years of state service.
