EXECUTIVE DIRECTOR'S REPORT

Budget, Workload Update and Tentative Agenda Items for the July 2025, September 2025, and December 2025 Meetings (info)

I. 2025-2026 Budget

A. The Commission's 2025-2026 Budget

The Governor introduced his proposed 2025-2026 budget on January 10, 2025 (AB 227, Gabriel; SB 65, Wiener). The Commission's 2025-2026 operating budget as proposed in the Governor's Budget is \$3,438,000 and is broken down as: \$2,981,000 for Personal Services and \$457,000 for Operating Expenses and Equipment. This is a decrease of \$124,000 from the total appropriation of \$3,562,000 for 2024-2025 after adjustments for salaries and benefits of \$33,000. On March 25, 2025, the Commission's budget was scheduled to be heard in Assembly Budget Subcommittee 5 as a non-presentation item and the outcome was held open.

The Governor's Budget also includes \$91,456,000¹ for Local Assistance or local agency mandated programs - a decrease of \$40,771,000 from the 2024-2025 budget of \$132,227,000.

2. 5180-151-0001 – For Local Assistance, Department of Social Services

Although local agency mandates are generally now funded through the Commission's budget, recent budgets (including for 2025-2026) make up to \$4 million dollars available in county-optional block grant funding through the Department of Social Services' budget, for allocation to local agencies to fund activities that are reimbursable under *Interagency Child Abuse and Neglect Investigation Reports*, 00-TC-22. Local governments that receive the block grant funding are not eligible to claim costs under section 17560 of the Government Code for any costs associated with the program. The State Department of Social Services, in consultation with the California State Association of Counties, shall develop the allocation methodology for distributing the funds to the participating counties. Block grant funding apportioned according to this item is subject to annual financial and compliance audits.

C. K-14 Mandate Funding and Suspension

Unlike local agency mandate funding, K-14 mandate funding takes place outside of the Commission's budget. Among other things, the Budget Bill (AB 227, Gabriel; SB 65, Wiener) does the following with regard to mandate funding.

This line item appropriates \$39.749 million for transfer to Section B of the State School Fund, Program 98-Community College Mandated Programs Block Grant. It further provides:

1. The funds appropriated in this item are for transfer by the Controller to Section B of the State School Fund. Pursuant to Section 17581.7 of the Government Code, the funds appropriated in this item shall be distributed to community college districts that elect to participate in the block grant on the basis of funded full-time equivalent students (FTES) calculated as of the second principal apportionment for the 2024–25 fiscal year multiplied by \$36.51 per FTES.
2. If total funding provided in this item is insufficient to fully fund the rate specified in Provision 1, the Chancellor of the California Community Colleges shall proportionately reduce the rate to conform to available funding.

6. 6870-403

This section has in the past provided for community colleges, pursuant to Section 17581.5 of the Government Code, a list of mandates that are specifically identified by the Legislature for suspension during the upcoming fiscal year. This section is currently absent from both budget bills.² Commission staff are in the process of following up in order to identify the reason for the omission.

II. Regulations Update

The subject of our 2025 Rulemaking will be a full review and update of the Commission's regulations to ensure clarity, consistency, and ease of use of the Commission's process for receiving and hearing claims. To this end, staff prepared draft proposed amendments which were reviewed and discussed with representatives from local government agencies at an informal conference on April 25, 2025 on Zoom. Attended by 31 participants, the informal conference was very successful with those providing feedback indicating that they felt it was very useful, helpful, and much appreciated. Informal comments on the proposed amendments received by staff both during and after the informal conference are proving to be invaluable as they are considered for inclusion in the amended regulations for future consideration by the Commission.
