CHAIRPERSON MILLER: Please proceed, Mr. Feller.

MR. FELLER: Good morning.

This IRC challenges the State Controller's reduction to reimbursement claims filed by the Fairfield-Suisun Unified School District for the Stull Act Program for fiscal years 2005-08 and 2010-2013. Parameters and guidelines authorize reimbursement for adding criteria to the already required written evaluations for certificated instructional personnel, and for adding an assessment and written evaluation every other year for certificated employees who previously received a nonsatisfactory evaluation.

Based on this record, the staff finds that the Controller's reduction of salary and benefit costs is correct, as a matter of law, because the claimant did not provide contemporaneous source documentation to support the time devoted to the reimbursable activities as required by the parameters and guidelines.

Staff also finds there's no evidence in the record that the Controller's allowance of 60 minutes per evaluation is arbitrary, capricious, or entirely lacking in evidentiary supports.

Staff recommends the Commission adopt the proposed decision to deny the IRC and to authorize staff to make

That is County of San Diego versus 4 Commission on State Mandates, which challenges the 5 6 Commission's decision on the Youth Offender Parole 7 Hearings test claim. And that's all I have. 8 9 MS. HALSEY: Thank you. 10 Next is the Executive Director's Report. 11 For my report today, the governor introduced the 12 budget in January, as you know, and it proposed funding 13 for the Commission's operational budget at essentially the same level as for 2019, with a very small 14 15 enhancement for increased OE&E costs. And the budget --16 the Commission's budget for local assistance -- the 17 other portion of the budget that's for mandate 18 reimbursement -- has been heard in both the assembly and 19 the senate, but the operational budget has yet to be 20 heard in the legislature. I'm not actually sure, but I think they might be 21 22 doing all operational budgets as part of negotiations 23 this year, with the administration, since they have 24 separated them out. 25

Anyway, that's the status, and we'll update that as

1 we get more information. 2 For Mandates, though, the funding was proposed 3 essentially to be the same as for 2019 except that the 4 new mandates which the Commission has found over the 5 last year are proposed to be funded at the higher end of 6 the range and the statewide cost estimates recently 7 adopted by the Commission. With regard to workload, after this hearing, we'll 8 have 42 test claims pending. 39 of those are regarding 9 10 stormwater, and we have a -- sorry. I think it's 11 11 IRCs pending and seven -- no. I'm sorry. I'm saying 12 that wrong. It's more than 11. Anyway, there are seven 13 consolidated together, and I think there's 11 total for 14 hearing. And we're going to be hearing that 15 consolidated one at the next hearing. It's been issued for comment. 16 17 And that is all I have on workload for now. CHAIRPERSON MILLER: Great. Thank you very much 18 19 for that. 20 Any questions for Ms. Halsey? 21 (No response) CHAIRPERSON MILLER: Any public comment for either 22 23 Ms. Halsey or Ms. Shelton? 24 MS. PALCHIK: I see none, Madam Chair. 25 Thank you very much. CHAIRPERSON MILLER: Great. 16
