EXECUTIVE SUMMARY

Overview

On March 4, 2021, the Santa Clara Valley Water District (claimant) filed a request to withdraw the Waste Discharge Requirements and Water Quality Certification for: Santa Clara Valley Water District and U.S. Army Corps of Engineers, Upper Berryessa Creek Flood Risk Management Project, 17-TC-04 Test Claim.¹

Section 1187.12 of the Commission's regulations provides, in pertinent part, that a test claim, or portion thereof, may be withdrawn by the claimant upon written application to the executive director any time before a decision is adopted or after enactment of a legislatively determined mandate on the same statute or executive order pursuant to Government Code section 17574. Dismissal of items withdrawn pursuant to this section shall be in accordance with the procedures described in section 1187.14 of these regulations.

Section 1187.14(b) of the Commission's regulations provide that a test claim that has been withdrawn or deemed abandoned may be dismissed by the Commission on its own motion or by a motion of a party after notice and an opportunity to be heard has been provided to the claimant, parties and interested parties as provided below:

(1) For test claims that are withdrawn, deemed abandoned, or filed by an agency that is not eligible to seek reimbursement because it is not subject to the taxing and spending limitations of article XIII A and B of the California Constitution, Commission staff shall serve written notice to initiate dismissal of the test claim to everyone on the mailing list for the matter. The notice shall announce that another local agency or school district may take over the claim by substitution of parties within 60 days of the issuance of the notice.

The notice shall also announce the opportunity to file written comments on the proposed dismissal of the test claim. A copy of the notice shall also be posted on the Commission's website.

- (2) Written comments shall be certified, filed, and served in accordance with section 1181.3 of these regulations. If representations of fact are made, they shall be supported by documentary or testimonial evidence in accordance with section 1187.5 of these regulations.
- (3) If no other local agency or school district takes over the test claim by substitution of parties within 60 days of the issuance of the notice, the Commission shall hear the proposed dismissal of the test claim.
- (4) The hearing on a dismissal of a test claim shall be conducted in accordance with article 7 of these regulations.

On March 5, 2021, the Claimant's Request to Withdraw the Test Claim was served in writing to all interested parties and persons on the mailing list for this Test Claim, and a 60-day notice of this withdrawal and dismissal was provided pursuant to California Code of Regulations, title 2, section 1187.14(b).²

The executive order that is the subject of this Test Claim (Order No. R2-2017-0014) applies only to the claimant and the U.S. Army Corps of Engineers.³ No interested parties objected to the claimant's request for withdrawal, or requested to take over the claim by substitution of the parties, on or before May 4, 2021.

Therefore, the sole issue before the Commission on State Mandates (Commission) is whether the Commission adopts the Proposed Decision, dismissing the above-named Test Claim.

Staff Recommendation

Staff recommends that the Commission adopt the Proposed Decision, dismissing the *Waste Discharge Requirements and Water Quality Certification for: Santa Clara Valley Water District and U.S. Army Corps of Engineers, Upper Berryessa Creek Flood Risk Management Project*, 17-TC-04 Test Claim.

Summary of the Findings

On March 4, 2021, the Santa Clara Valley Water District (claimant) filed a request to withdraw the Test Claim *Waste Discharge Requirements and Water Quality Certification for: Santa Clara Valley Water District and U.S. Army Corps of Engineers, Upper Berryessa Creek Flood Risk Management Project,* 17-TC-04.⁴ On March 5, 2021, the claimant's request was served in writing to all interested parties and
