Senior Commission Counsel Raj Dixit presented this item and stated that this is the first of two hearings in the mandate redetermination process. Mr. Dixit recommended that the Commission adopt the Decision finding that Finance had made an adequate showing and direct staff to notice the second hearing to determine if a new test claim decision shall be adopted to supersede the previously adopted Test Claim Decision.

13 MS. HALSEY: Ms. Lee.

14 MEMBER LEE: Here.

15 MS. HALSEY: Ms. Olsen.

16 MEMBER OLSEN: Here.

17 MS. HALSEY: Ms. Ramirez.

18 MEMBER RAMIREZ: Here.

19 MS. HALSEY: Ms. Wong-Hernandez.

20 MEMBER WONG-HERNANDEZ: Here.

21 CHAIRPERSON BOSLER: All right. We'll start with
22 the minutes.

23 Are there any objections or corrections to the
24 May 24th minutes?

25 MEMBER OLSEN: Move adoption.

1 MEMBER RAMIREZ: Second.

2 CHAIRPERSON BOSLER: It's been moved and seconded.

3 So we have a motion and a second to adopt the
4 May 24th minutes. All those in favor of adopting the
5 minutes, please signify by saying "aye."

6 (Ayes)

7 CHAIRPERSON BOSLER: The minutes are adopted.

8 MS. HALSEY: Now we will take up -- my microphone
9 is not working. These microphones are not on. I should
10 say, this panel. Sorry. I am just going to speak up.
11 Thank you.

12 And now we will take up public comment for matters
13 not on the agenda. Please note that the Commission
14 cannot take action on items not on the agenda. However,
15 it can schedule issues raised by the public for
16 consideration at future meetings.

17 CHAIRPERSON BOSLER: Is there anyone who wants to
18 bring any public comment forward that's not related to
19 the agenda?

20 (No response)

21 CHAIRPERSON BOSLER: All right. It looks like
22 there is none.

23 MS. HALSEY: Moving on, Items 3, 7, and 8 are
24 proposed for consent.

25 MEMBER RAMIREZ: I move the recommended action.

1 CHAIRPERSON BOSLER: All right. We have a motion
2 to move the proposed consent calendar.

3 Is there a --

4 MEMBER WONG-HERNANDEZ: Second.

5 CHAIRPERSON BOSLER: There's a second.

6 The motion has been moved and seconded.

7 All those in favor, signify by saying "aye."

8 (Ayes)

9 MS. HALSEY: Public comment?

10 CHAIRPERSON BOSLER: Oh, sorry.

11 Is there any public comment on the consent
12 calendar?

13 (No response)

14 CHAIRPERSON BOSLER: No. Okay. A lot of
15 procedural things today.

16 So those -- those in favor, signify by saying
17 "aye."

18 (Ayes)

19 CHAIRPERSON BOSLER: Motion is carried.

20 MS. HALSEY: Thank you.

21 Let's move to the Article 7 portion of the hearing.
22 Item 4, Test Claim on Youth Offender Parole Hearings,
23 has been postponed to the September hearing at the
24 request of the claimant.

25 Will the parties and witnesses for Item 5 please

1 rise.

2 (Parties/witnesses stood to be sworn or
3 affirmed.)

4 MS. HALSEY: Thank you.

5 Item 2 is reserved for appeals of Executive
6 Director decisions. There are no appeals to consider
7 for this hearing.

8 Next is Item 5. Senior Commission Counsel Raj
9 Dixit will present a request for mandate redetermination
10 on high school exit examination. At this time, we
11 invite the parties and witnesses for Item 5 to please
12 come to the table.

13 MR. DIXIT: Good morning, ladies and gentlemen.

14 This mandate redetermination requests that the
15 Commission adopt a new test claim decision to end the
16 State's liability for the high school exit examination,
17 or the "exam" -- I will call that here on out -- based
18 on a subsequent change in law. The subsequent change in
19 law arises from statutes that first suspended the
20 administration of the exam and the requirement that
21 every student pass the exam to receive a diploma. That
22 repealed the statutes that impose the mandate.

23 After the request for redetermination was filed,
24 the regulations that implemented the mandated program
25 were repealed.

1 Pursuant to the Government Code and the
2 Commission's regulations, this is the first of two
3 hearings in the mandate redetermination process. This
4 first hearing is limited to determining only whether the
5 requester has made an adequate showing that the State's
6 liability has been modified based on a subsequent change
7 in law.

8 Staff finds that Finance has made an adequate
9 showing that the State's liability has been modified
10 based on a subsequent change in law, and that there is a
11 substantial possibility that the request will prevail at
12 the second hearing. Accordingly, staff recommends that
13 the Commission adopt the proposed decision and direct
14 staff to notice the second hearing for September 27th,
15 2019, to determine if a new test claim decision shall be
16 adopted to supercede the previously adopted test claim
17 decision.

18 Further, staff requests authorization to make any
19 technical, nonsubstantive changes to the proposed
20 decision following the hearing.

21 Thank you.

22 CHAIRPERSON BOSLER: We will go with the parties
23 and witnesses stating their names for the record.

24 MS. ALEXANDER: Amber Alexander with Department of
25 Finance.

1 CHAIRPERSON BOSLER: And then we will go to public
2 comment.

3 Is there any public comment on this item?

4 (No response)

5 CHAIRPERSON BOSLER: Do any of the commission
6 members have any questions about this item?

7 MEMBER OLSEN: I will move the staff
8 recommendation.

9 CHAIRPERSON BOSLER: Thank you.

10 We have a motion.

11 MEMBER HARIRI: Second.

12 CHAIRPERSON BOSLER: There's been a motion and a
13 second.

14 Heather, please call the roll.

15 MS. HALSEY: Mr. Adams.

16 MEMBER ADAMS: Aye.

17 MS. HALSEY: Ms. Bosler.

18 CHAIRPERSON BOSLER: Aye.

19 MS. HALSEY: Mr. Hariri.

20 MEMBER HARIRI: Aye.

21 MS. HALSEY: Ms. Lee.

22 MEMBER LEE: Aye.

23 MS. HALSEY: Ms. Olsen.

24 MEMBER OLSEN: Aye.

25 MS. HALSEY: Ms. Ramirez.

1 MEMBER RAMIREZ: Aye.

2 MS. HALSEY: Ms. Wong-Hernandez.

3 MEMBER WONG-HERNANDEZ: Aye.

4 MS. HALSEY: Motion carries.

5 CHAIRPERSON BOSLER: Motion has carried.

6 Thank you.

7 MS. HALSEY: Item 6 is reserved for county
8 applications for a finding of significant financial
9 distress, or SB 1033 applications. No SB1033
10 applications have been filed.

11 Item 7 and 8 were on the consent calendar.

12 Item 9 is next. Program Analyst Kerry Ortman will
13 present this item, the legislative update.

14 MS. ORTMAN: Good morning.

15 We've been monitoring three bills:

16 First, SB 287, Commission on State Mandates, Test
17 Claims Filing Date, which proposes language that would
18 specify that for purposes of filing a test claim based
19 on the date of incurring increased costs, the phrase
20 "within 12 months" means by June 30 of the fiscal year
21 following the fiscal year in which increased costs were
22 first incurred by the test claimant. On June 26 the
23 bill was placed on the Assembly Appropriations Suspense
24 File.

25 Next, AB 400, State Mandates, is a spot bill,

1 according to the author's office.

2 And, finally, AB 1471, State-Mandated Local Costs
3 Notification. This proposes language that would specify
4 that reimbursement of lost revenue be provided to
5 certain level agencies as a result of delayed State
6 action pursuant to the same procedures as filing a test
7 claim with the Commission.

8 Also, the provisions of this bill would exempt from
9 the exceptions under Government Code 17556. This bill
10 did not make it out of the house -- of its house of
11 origin by the deadline, and, as a result, it may become
12 a two-year bill and could be acted on when the
13 Legislature reconvenes in 2020. And staff will continue
14 to monitor legislation for bills that impact the
15 mandates process.

16 Thank you.

17 CHAIRPERSON BOSLER: Thank you.

18 MS. HALSEY: Item 10, Chief Legal Counsel Report.
19 Camille Shelton will present this item.

20 MS. SHELTON: Good morning.

21 We do have one new petition for writ of mandate
22 filed by the City of San Diego that challenges the
23 Commission's decision in lead sampling in schools'
24 public water system. That petition was served July 10,
25 2019.

1 We also have a recent decision by the California
2 Supreme Court denying the petition for rereview in
3 Paradise Irrigation District. With that denial, that
4 means that the Court of Appeals's decision is now final,
5 and that decision holds that claimants continue to have
6 the legal authority to levy fees even if that authority
7 is subject to the majority protest provisions of
8 Proposition 218.

9 There is one court hearing date scheduled for the
10 remand of the Department of Finance and -- versus County
11 of San Diego and the Commission on State Mandate case
12 dealing with discharge of stormwater runoff. That
13 hearing is now scheduled for December 6.

14 And that's all I have.

15 CHAIRPERSON BOSLER: Thank you.

16 MS. HALSEY: Next is Item 11, the Executive
17 Director Report.

18 The Governor signed the 2019 Budget Act which
19 included, with regard to mandates, a one-time payment of
20 15.1 million to repay local agencies for costs incurred
21 for four mandates that have been identified by the
22 Legislature as expired or repealed. Repayment
23 represents the retirement of state obligations to local
24 agencies for costs incurred between 2004 and 2011 for
25 the following programs: Binding arbitration, fire

1 safety inspections of care facilities, local
2 recreational areas background screenings, and racial
3 profiling local law -- sorry, law enforcement training.

4 The budget also provides up to \$4 million for a
5 county-optional block grant program administered by the
6 Department of Social Services for the Interagency Child
7 Abuse and Neglect Investigation Reports, or ICAN
8 program.

9 Also, the Commission's operating budget was
10 approved as proposed, and it includes the addition of an
11 additional one half PY for a human resources program
12 analyst.

13 And with regard to our workload, after this
14 hearing, there are four pending -- 40 pending test
15 claims, 39 of which are regarding stormwater NPDES
16 permits. And there are also two active parameters and
17 guidelines, two statewide cost estimates, and two
18 statewide cost estimates that are active and pending.
19 In addition, there's one more parameters and guidelines
20 and another statewide cost estimate, which are both on
21 inactive status pending the outcome of litigation
22 regarding the test claim decisions underlying those
23 matters.

24 There's also one parameters and guidelines
25 amendment on inactive status pending the outcome of

1 litigation in the CSBA case, which is currently pending
2 before the California Supreme Court.

3 And we have three requests for mandate
4 redetermination currently pending, one of which is on
5 remand from the court.

6 And finally, there are five incorrect reduction
7 claims pending.

8 Commission staff currently expects to complete all
9 currently pending test claims and IRCs by approximately
10 the December 2022 Commission meeting depending on
11 staffing and other workload. And some of the test
12 claims may be heard and decided earlier than currently
13 indicated if they are consolidated for hearing.

14 That's what I have.

15 Any questions on any of that?

16 (No response)

17 MS. HALSEY: No? Okay.

18 Moving on then, to closed session.

19 CHAIRPERSON BOSLER: So the Commission will now
20 meet in closed executive session. Pursuant to
21 Government Code section 11126(e) to confer with and
22 receive advice from legal counsel for consideration and
23 action, as necessary and appropriate, upon the pending
24 litigation listed on the published notice and agenda;
25 and to confer with and receive advice from legal counsel

1 regarding potential litigation. The Commission will
2 also confer on personnel matters pursuant to Government
3 Code section 11126(a) (1).

4 We will reconvene in open session in approximately
5 15 minutes, for all of those of you who want to come
6 back.

7 (Closed session was held from
8 10:15 a.m. to 10:24 a.m.)

9 CHAIRPERSON BOSLER: So with no further business to
10 discuss -- I'm looking around -- is there any other
11 further business?

12 (No response)

13 CHAIRPERSON BOSLER: I will entertain a motion to
14 adjourn.

15 MEMBER OLSEN: So moved.

16 MEMBER RAMIREZ: Second.

17 CHAIRPERSON BOSLER: Moved and seconded.

18 All those in favor.

19 (Ayes)

20 MS. PALCHIK: You have to bring us back. It's
21 required to be read.

22 CHAIRPERSON BOSLER: Where is it?

23 MS. HALSEY: Page 6.

24 CHAIRPERSON BOSLER: Okay. The Commission met in
25 closed executive session pursuant to Government Code

1 section 11126(e) (2) to confer with and receive advice
2 from legal counsel for consideration and action, as
3 necessary and appropriate, upon the pending litigation
4 listed on the published notice and agenda; and to confer
5 with and receive advice from legal counsel regarding
6 potential litigation and pursuant to Government Code
7 section 11126(a) (1) to confer on personnel matters.

8 With no further business, I will entertain a motion
9 to adjourn.

10 All those in favor of adjourning.

11 (Ayes)

12 CHAIRPERSON BOSLER: The meeting is adjourned.

13 (Proceedings concluded at 10:26 a.m.)
