There are no appeals to consider 7 for this hearing. 8 Next is Item 3. Senior Commission Counsel Eric 9 Feller will please present a proposed decision on 10 Disclosure Requirements and Deferral of Property 11 Taxation, 22-TC-06. 12 MR. FELLER: Good morning. The test claim statute 13 requires Los Angeles County and other counties that opt 14 in to the program to defer property tax payments without 15 penalty or interest for property owners claiming relief 16 under Proposition 19 and its implementation statute 17 until the County Assessor determines the owner's claim. 18 Proposition 19, adopted in November 2020, allows 19 property owners who are over 55, severely disabled, or 20 victims of a wildfire or natural disaster transfer the 21 taxable base year value of their primary residence to a 22 replacement primary residence anywhere in the state 23 within two years of the sale of original primary 24 residence to prevent or mitigate increased property 25 taxes when the owners move or rebuild. 16

1	Under the test claim statute, deferment requests
2	must be filed with the County within one year of
3	receiving the first tax bill for the replacement
4	property but before January 1, 2024. And the provisions
5	sunsets on January 1, 2026.
6	The other part of the test claim statute which does
7	not sunset requires L.A. County to print brief summaries
8	on property tax bills about the availability of
9	property of Proposition 19 base year value transfers
10	and tax deferment availability under the test claim
11	statute.
12	Staff finds that the test claim statute imposed a
13	reimbursable state-mandated program on only the County
14	of Los Angeles. Other counties that opt in to the
15	program are not mandated by the State to comply.
16	Staff recommends the Commission approve this test
17	claim, the reimbursement period beginning December 28,
18	2022, and authorize staff to make any technical,
19	nonsubstantive changes following the hearing.
20	VICE CHAIRPERSON PAHLAND: Parties and witnesses,

22	all-gender restrooms, and at least one men's restrooms
23	with an adequate supply of menstrual products at all
24	times free of charge for pupils on or before the start
25	of the 2023 school year, in addition to posting a notice
	20

1 about the products' availability.

The proposed parameters and guidelines include the activities mandated by the test claim statute and the recently necessary activity to purchase and install or repair or retrofit dispensers to provide menstrual products.

7 Staff also finds that limiting the restrooms 8 required to be stocked with menstrual products to pupil restrooms, as required by Finance, is inconsistent with 9 10 the test claim statute and therefore denied but that 11 stating reimbursement is not required to stock more than 12 one men's restroom per school, as suggested by Finance, 13 as a clarifying edit included in the proposed P&Gs. 14 So the proposed parameters and guidelines also 15 require claimants to report specified information with 16 their reimbursement claims in order to support the increased level of service and the actual cost claimed. 17 18 So staff recommends the Commission adopt the 19 proposed decision and parameters and guidelines and 20 authorize staff to make any technical, nonsubstantive 21 changes following the hearing. 22 VICE CHAIRPERSON PAHLAND: Okay. 8	Assembly Committee on Local Government.
9	On May 3rd, 2024, the assembly member's office
10	confirmed that there are no plans for it to move forward
11	at this time.

1	Next is Item 10, the Executive Director Report.
2	The Budget Act of 2024 was chaptered on June 29th,
3	2024 or and June 26th, 2024. Sorry. It came in
4	two bills. And the Commission's budget was adopted as
5	proposed. However, the budget includes language
6	requiring a 7.95 percent reduction in operating budget
7	and also a sweep of vacant positions.
8	We expect budget letters soon that will detail how
9	the Commission will be taking these cuts.
10	For workload: After this hearing, there are
11	37 pending test claims, 35 of which are regarding
12	stormwater.
13	There are two parameters and guidelines pending,
14	including one regarding stormwater.
15	And there are five statewide cost estimates and one
16	incorrect reduction claim pending.
17	Staff expects to complete all the currently pending
18	test claims and IRCs by approximately the December 2026
19	Commission meeting, depending on staff and workload.
20	For tentative agenda items, please see the full
21	Executive Director's Report, and you will see the items
22	we expect to hear in the next couple of hearings.
23	We also include a pending caseload document that's
24	on our website, that we update at least bimonthly, that
25	contains all of our caseload and when we expect the
	27

1	individual items to be heard.
2	And that's all I have for my Executive Director
3	Report today.
