Dear Ms. Higashi:

As requested in your letters dated October 7, 2003, and February 19, 2004, the Department of Finance has reviewed the draft analysis of Test Claim Numbers CSM-00-TC-09, CSM-00-TC-13, and CSM-02-TC-32, submitted by the Empire Union Unified School District, Sweetwater Union High School District, and Bakersfield City School District (claimants), asking the Commission to determine whether specified costs incurred under various chaptered legislation are reimbursable State mandated costs.

Finance previously stated in our letter dated September 24, 2003, regarding the test claims submitted by Empire Union School District (CSM-00-TC-13 School Accountability Report Card II), Sweetwater Union High School District, and Bakersfield City School District (CSM-02-TC-32 School Accountability Report Card III), that while some of the activities addressed in those claims are reimbursable, the incremental cost of including that information in an accountability report card should be minimal.

We revise our previous analysis and concur with the staff analysis for these claims, which finds that the proposed activities do not impose a new program or higher level of service than that imposed by the voters in the Constitution, and therefore does not impose reimbursable costs mandated by the State. The changes cited are so minimal in extent and cost that they do not rise to a "higher level of service."

As required by the Commission's regulations, we are including a "Proof of Service" indicating that the parties included on the mailing list which accompanied your February 19, 2004, letter have been provided with copies of this letter via either United States Mail or, in the case of other State agencies, Interagency Mail Service.
