Dear Mr. Petersen and Ms. Jamison:

On June 3, 2004, I notified the parties of my decision to expedite the above matters by severing Title 5, California Code of Regulations sections 11510 – 11517 from 03-TC-06, California English Language Development Test II and consolidating them with 00-TC-16, California English Language Development Test.

Claimant's representative Keith Petersen, by letter dated June 7, 2004 objected to this decision. In a letter dated June 23, 2004, Mr. Petersen appealed the decision and requested that the test claims be consolidated.

Upon further consideration and review of Mr. Petersen's June 7th objection, I am rescinding my decision to sever California Code of Regulations, title 5, sections 11510 - 11517 from the CELDT II test claim. Both CELDT I and CELDT II will remain as pled. Therefore, the appeal of June 23, 2004 is most and will not be scheduled for hearing.

As to the June 23, 2004 request to consolidate the CELDT I and CELDT II claims, it is denied as untimely. Section 1183.05 of the Commission's regulations requires a motion to consolidate to be filed within 30 days of filing a completed test claim. The CELDT II test claim was deemed complete on June 25, 2001.
