On behalf of the County of Santa Clara, I am requesting an extension to submit the County's rebuttal to the State Controller Office's comments on Incorrect Reduction Claim 07-4509-I-02.

The County is requesting the extension because there have been retirements and staff changes since the time when the County submitted the claim, July 25, 2007, and the time when the State Controller's Office submitted its comments, January 29, 2015. Deputy County Counsel Lizanne Reynolds, who was the lead on the County's submission, retired in August 2014. In addition, there have been recent staffing changes in the Finance Agency, including the retirement of the Controller-Treasurer in December 2014. Therefore, the County requires additional time so that appropriate staff can review the County's claim and competently consider and respond to the State Controller Office's comments.
