Dear Ms. Halsey:

Pursuant to Title 2, California Code of Regulations (“CCR”) section 1187.9(a), Claimant Los Rios Community College District (“Claimant”) respectfully requests an extension of time of 90 days in which to submit a response to the State Controller’s Office (“SCO”) comments filed on October 13, 2014, in regards to the above referenced Incorrect Reduction Claim (“IRC”).

Claimant respectfully requests this extension in order to allow sufficient time to review the files from former Claimant Representative Keith Petersen and to prepare a rebuttal to SCO’s comments. Claimant was notified by Mr. Petersen via letter dated September 30, 2014, which was received by Claimant on October 3, 2014, that Mr. Petersen was terminating its services with Claimant, effective immediately. Pursuant to an October 2, 2014, email from Mr. Petersen to Jason Hone and Heidi Palchik at the Commission, in which Claimant was copied, Mr. Petersen notified the Commission that he no longer represents Claimant.
