

Re: Notice of Change in Test Claim Case Number and Waiver of Section 1183, Subdivision (h)(3) of the Commission's Regulations

Santa Ana Region Water Permit (California Regional Water Quality Control Board, Santa Ana Region, Order No. R8-2009-0030), Test Claim Number 09-TC-03 County of Orange, Orange County Flood Control District; Cities of Anaheim, Brea, Buena Park, Costa Mesa, Cypress, Fountain Valley, Fullerton, Huntington Beach, Irvine, Lake Forest, Newport Beach, Placentia, Seal Beach, and Villa Park, Co-Claimants

This notice corrects the July 9, 2010 "Notice of Complete Test Claim Filing and Schedule for Comments and Notice of Consolidation of Test Claims."

On June 30, 2010, a test claim was filed on the California Regional Water Quality Control Board, Santa Ana Region Order No. R8-2009-0030 by the County of Orange, Orange County Flood Control District (OCFCD) and the cities of Anaheim, Brea, Buena Park, Costa Mesa, Cypress, Fountain Valley, Fullerton, Huntington Beach, Irvine, Lake Forest, Newport Beach, Placentia, Seal Beach and Villa Park. The Commission originally treated this filing as several



test claims filed on the same executive order and individual case numbers were assigned to each local agency filing a face sheet.

Government Code section 17521 defines "test claim" as the first claim filed with the commission alleging that a particular statute or executive order imposes costs mandated by the state. Thus, there can be only one test claim on the same statute or executive order.

Further, section 1183, subdivision (h) of the Commission's regulations provide that a test claim may be prepared as a joint effort between two or more claimants if the claimants attest to all of the following in the test claim filing:

- (1) The claimants allege state-mandated costs result from the same statute or executive order;
- (2) The claimants agree on all issues of the test claim; and,
- (3) The claimants have designated one contact person to act as the resource for information regarding the test claim.

Although the test claim includes evidence of paragraphs (1) and (2), there is no evidence in the filings that the claimants have designated one contact person to act as the resource for information regarding the test claim. Each local agency has filed an individual face sheet with contact information and designated a different representative for the test claim filing. Thus, in order to allow all local agencies to participate as co-claimants on this test claim, it is necessary to waive section 1183, subdivision (h)(3), pursuant to Government Code section 17554 which allows the commission to waive the application of any procedural requirements imposed by this chapter or pursuant to Government Code section 17553 with the agreement of all parties to the claim.

Therefore, all future correspondence and filings on the test claim shall be identified as "Santa Ana Region Water Permit, 09-TC-03," and the local agencies identified above will be described as co-claimants.
