
On behalf of the District, I am requesting an extension to move the hearing date on the above referenced matters (07-904133-05, 10-904133-07, and 13-904133-11) from September 25, 2015, to December 3, 2015, and an extension for response to the two July 31, 2015, Draft Proposed Decisions. I also request the incorrect reduction for the second audit (10-904133-09), for which no Draft Proposed Decision has yet been released, be heard at the same hearing.

The staff analysis includes several threshold legal issues of first impression applicable to the eleven years audited in the three San Juan Unified School District incorrect reduction claims and six pending incorrect reduction claims for Riverside Unified School District, the scope of which were not refined until the Draft Proposed Decisions were released last week. The Draft Proposed Decisions are the result of many months of Commission staff work and the District's response will require similar consideration.

I also have competing Commission workload. I am representing other Districts on other incorrect reduction claims that appear to be scheduled for every hearing date, both in the short term and the long term. I am also responding to several Controller audits which the Controller staff is endeavoring to complete before their statute of limitations to complete an audit expires. I cannot delegate any of this work to support staff.


