Dear Mr. Rice:

On September 20, 2017, the Commission on State Mandates (Commission) received the State Water Resources Control Board and the Santa Ana Regional Water Permit – County of San Bernardino (collectively Water Boards) request for extension to respond to the Joint Test Claim for the above-captioned Test Claim. Specifically, the request states that Claimants require a 90-day extension until January 10, 2018 because you are responsible for other priority duties that limit your ability to work exclusively on Test Claim matters. Also, you are scheduled for paternity leave in late September through October and are the Santa Ana Water Board's sole legal counsel and the only attorney assigned to this Test Claim on behalf of both the Santa Ana Water Board and the State Water Board.

However, because an extension of more than 60-days would cause a delay in the closing of this record and analysis by Commission staff, the approval of your request for an extension of time is limited to 60-days for good cause, your response to the Joint Test Claim Filing for all claimants is now due by **December 11, 2017**.

Section 1187.9(a) of the Commission's regulations provide that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request shall be approved.

The Commission would also like to inform you that 09-TC-03 is now tentatively set for hearing January 26, 2018.

This matter remains tentatively set for hearing on July 27, 2018.


