Dear Ms. Halsey:

By letter dated July 13, 2011, the Commission on State Mandates (Commission) issued a notice of complete test claim filing and schedule for comments in the above-referenced matter, with all comments originally due on or before August 12, 2011. The Commission has granted the State Water Resources Control Board's (State Water Board) and San Diego Regional Water Quality Control Board's (San Diego Water Board) (collectively Water Boards) subsequent requests for extensions of time to submit comments on behalf of both Water Boards, with comments now due on or before August 13, 2013.

I am the attorney assigned to this Test Claim on behalf of the Water Boards. Since the above matter is not yet set for hearing due to the backlog and pending litigation relating to similar test claims, as identified in the Commission's earlier letters granting extensions of time, the Water Boards request an additional extension of time for submitting written comments in this matter. Section 1183.01(c)(1)(A) of the Commission's regulations provides that extension by stipulation shall be approved by the executive director for good cause.

I am authorized by counsel for the Test Claimants in the above matter, Geoffrey Hunt, to represent that the Test Claimants do not object to an extension of time for the filing of

Accordingly, the Water Boards request that the Commission grant such an extension of time and establish a new deadline for submitting Water Board comments of January 14, 2014.
