This action will be effective 10 days from the service of this notice. If a party wishes to appeal this action, the appellant may do so pursuant to section 1181.1(c) of the Commission's regulations.

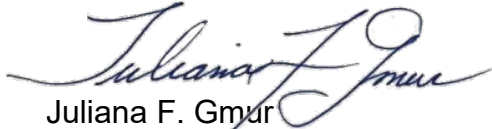
