Dear Ms. Froelich:

On September 19, 2017, the Commission on State Mandates (Commission) received the California Regional Water Quality Control Board, San Diego Region and the State Water Resources Control Board (collectively Water Boards) third request for an extension of time to file the administrative record and comments on the above-captioned Test Claim.

Specifically, the request states that the Water Boards require another 30-day extension beyond the current deadline of October 9, 2017 to file written comments on the Test Claim and to prepare the administrative record for the permit due to the volume and complexity of the revised Test Claim and its attachments. Also, a new Water Board attorney has been assigned to this matter and requires the additional time to review the record and consult with staff to draft the response to the Test Claim.

Section 1187.9(a) of the Commission's regulations provide that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request shall be approved.

Therefore, Water Boards' response is now due **November 8, 2017**.

This matter remains tentatively set for September 28, 2018.


