REQUEST FOR EXTENSION OF TIME TO SUBMIT COMMENTS AND TO SUBMIT THE ADMINISTRATIVE RECORD FOR ORDER NO. R9-2013-0001 ("Test Claim 14-TC-03")

Dear Ms. Halsey:

I write to request a fourth extension of time to respond to Test Claim 14-TC-03.

As the Commission knows, I have been asked to draft the California Regional Water Quality Control Board, San Diego Region's ("San Diego Water Board") and the State Water Resources Control Board's ("State Water Board") (together, the "Water Boards") Response to Test Claim 14-TC-03. Currently, the Water Boards' response to Test Claim 14-TC-03 is due November 9, 2017. The response time has been extended three times by the Commission on State Mandates ("Commission"), most recently by the Notice of Extension Request Approval Letter dated September 21, 2017. (See <https://www.csm.ca.gov/matters/14-TC-03/doc10.pdf>.) For the reasons set forth below, the Water Boards request an additional 37 days, until **December 15, 2017**, to respond to Test Claim 14-TC-03.

I recently joined the Water Board staff as an attorney, and I have been asked to respond to Test Claim 14-TC-03. The Water Boards want to closely evaluate Test Claim 14-TC-03 and the numerous provisions alleged to be unfunded state mandates, as well as the funding source and authority issues identified by the Commission in its Notice. The Water Boards do not believe they will be able to do so and submit the administrative record for the underlying permit by November 8, 2017. Inclusive of attachments, the revised Test Claim exceeds 1000 pages and identifies at least eight separate permit provisions as unfunded mandates. I have started drafting the response and I have realized that it will require more attorney and staff time to research and prepare a thorough response and finalize the preparation of the record for the underlying permit than I originally anticipated.¹ I need additional time to get up to speed, review

¹ Although the administrative record is largely prepared, it will need to be reviewed, tailored and modified for this particular Test Claim, because it was originally prepared for a different matter.

the record, consult with San Diego Water Board's staff, and adequately respond to Test Claim 14-TC-03.

Section 1187.9(a) of the Commission's regulations provides that, as long as a postponement of the hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for a denial, a request for extension of time to file comments shall be approved. In this case, the Water Boards do not believe that postponement of the actual hearing (tentatively scheduled for next year, on September 28, 2018) will be required if the extension is granted. Similarly, the Water Boards are not aware of any prejudice to any party or interested party, or any other good reason, to deny the request for more time to respond. Accordingly, and for the reasons set forth above, the Water Boards respectfully request that the deadline for submission of written comments on the Test Claim and the administrative record for the underlying permit be extended for 37 days, to December 15, 2017.


