This office represents the County of San Diego in the above-referenced Test Claim No. 14-TC-03. On behalf of the County, we respectfully request that Test Claim be placed on inactive status.

This request is being made due to the pendency of the matter before the California Supreme Court addressing the test claim filed with respect to the Los Angeles County 2001 stormwater permit. It is likely that the Supreme Court's decision will clarify potentially controlling legal issues making further proceedings on the above-referenced test claims at this time inefficient. I have discussed this request with Catherine George Hagan, Senior Staff Counsel at the Office of Chief Counsel for the State Water Resources Control Board and Kathleen Lynch at the California Department of Finance. Both Ms. Hagan and Ms. Lynch have indicated that they support the placement of this test claim on inactive status.

It is our understanding that inactive status preserves the filing date of both test claims and that, once placed back on active status, any further briefing and consideration of the test claim would proceed on schedule.


