Dear Mr. Newmark:

On April 19, 2018, the Commission on State Mandates (Commission) received the claimant's request for a 30-day extension to file combined rebuttal comments to the San Francisco Regional Water Quality Control Board's comments and the Department of Finance's comment's on the above-captioned Test Claim.

Specifically, the request states that the comments submitted by the Regional Water Board are voluminous and raise numerous and complex issues. In addition, representative staff has been unavailable due to court-ordered mediation proceedings.

Section 1187.9(a) of the Commission's regulations provide that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request shall be approved.

Therefore, claimant's rebuttal comments are now due **May 29, 2018**. This matter will be tentatively set for hearing on March 22, 2019 on the next pending caseload update.¹
