Dear Ms. Palchik:

This provides an update to our January 16, 2018 notice. We are having difficulty complying with your January 11, 2018 emailed request to submit the attachments to our January 10, 2018 submission in a single PDF file without password protection.

While we are making progress in converting the files to the appropriate format, it is labor-intensive and time-consuming. The Dischargers were unwilling to provide us with unprotected PDF files of the attachments. They initially agreed to Bates-number and combine the attachments while retaining the password protection, but corrupted files prevented them from completing this task. With persistence, Regional Board staff was able to unlock the documents and work around the corrupted files in Attachments 4-5, but the process is still slow. We have converted Attachments 2-5 to the required format; Attachments 6-9 remain. In addition, as Regional Board staff are adding Bates numbers to the documents, Adobe Acrobat will not Bates number some documents because of a variety of technical issues. Troubleshooting each technical issue is labor-intensive and at times, staff has to physically print and scan the documents to facilitate Bates-numbering.

As a result of these issues, we must extend our estimate to resubmit the documents to early next week, tentatively by Wednesday, January 31.


