Dear Ms. Hagan:

On August 14, 2018, the Commission on State Mandates (Commission) received the State Water Resources Control Board's and the San Diego Regional Water Quality Control Board's (Water Boards') fifth request for an extension of time to file comments on the above-named Test Claim.

The Water Boards request a 14-day extension due to competing priorities associated with active litigation matters involving the Regional Board; significant permitting and cleanup matters as well as numerous time-intensive California Public Record Act requests.

On June 14, 2018, the Commission granted a 60-day extension in response to the board's fourth 30-day extension request, and yet the Board is now again requesting another extension. The Commission is now granting what should be the very last extension, again for 60 days, to avoid having to divert staff to respond to yet another request for extension on this matter.

Section 1187.9(a) of the Commission's regulations provide that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request shall be approved.

Therefore, the Commission approves a final 60-day extension to comment on the test claim filing. Thus, the Water Boards have been provided 240 days to file comments on the Test Claim, rather than the statutory 30 days. Please note that if the claimants request and receive as many extensions for its rebuttal as the Water Boards have received, this matter will indeed need to be postponed. The Water Boards' comments are now due **October 15, 2018** and the claimants' rebuttal comments are due 30 days from the service of the Water Boards' comments.

This matter is tentatively set for **November 29, 2019**, as November 22, 2019 is a holiday.


