Dear Ms. Halsey:

I am writing this letter on behalf of test claimants Riverside County Flood Control and Water Conservation District, County of Riverside and the Cities of Murrieta, Temecula and Wildomar ("Joint Test Claimants") to request an extension of time to **January 15, 2019** for the filing of rebuttal comments on the test claim. I am the designated Claimant Representative for all Joint Test Claimants. The rebuttal comments are currently due to be filed on **November 15, 2018** with respect to the comments of the Department of Finance and the State Water Resources Control Board and the San Diego Water Board.

Due to the number of issues in this Joint Test Claim and the need to review with the claimants the rebuttal papers, the Joint Test Claimants are requesting the above-noted extension of time.

The Commission is presently scheduled to hear this test claim on May 22, 2020. 
