Dear Mr. Burhenn and Ms. Hagan:

On April 10, 2018, the Commission on State Mandates (Commission) received claimants' request for an extension of time to file rebuttal comments to the Department of Finance's (Finance's) comments on the above-named Test Claim, currently due on April 16, 2018.

On April 11, 2018, the Commission received the State Water Resources Control Board and the San Diego Regional Water Quality Control Board's (Water Boards') second request for an extension of time to file comments on the above-named Test Claim, currently also due on April 16, 2018.

The Water Boards request a 30-day extension due to competing priorities associated with active litigation matters involving the Regional Board, in addition to significant permitting and cleanup matters, and numerous, extensive California Public Record Act request responses.

In addition, the claimants request to file combined rebuttal comments to Finance's Comments on the Test Claim, served on March 16, 2018, and to the Water Boards' comments, 30 days from the service of the Water Boards' comments.

Section 1183.3(a) of the Commission's regulations provide that written rebuttals to written comments concerning a test claim may be filed, and shall be certified, filed, and served in accordance with section 1181.3 of these regulations within 30 days of service of the written comments.

Section 1187.9(a) of the Commission's regulations provide that so long as a postponement of a hearing would not be required, there is no prejudice to any party or interested party, and there is no other good reason for denial, the request shall be approved.

Therefore, the Water Boards' comments are now due on May 16, 2018, and the claimants' request for extension of the 30-day rebuttal period in order to file combined rebuttal comments 30 days from the service of the Water Boards' comments is granted pursuant to sections 1183.3 and 1187.9(a) of the Commission's regulations.




